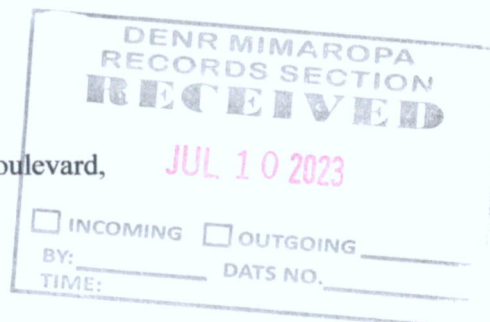

April 12, 2023	Olive Ridley	12	90 eggs were unmerged. Properly released. (Report already forwarded to the PENRO)
