## NARRATIVE

The Department of Environment and Natural Resources (DENR) is the primary agency assigned to protect the Countries Environment and Natural resources. Wildlife Transport Monitoring is one of the Activity performed by the Enforcement and Monitoring Section (EMS) of DENR-CENRO Sablayan, covering Sablayan and all the areas of MAPSA Municipalities. Part of the undertakings is to check and inspect all suspected vehicle that may carry wildlife or other illegal forest product.

On June 2, 2023, Civil Aviation Authority of the Philippines, Mamburao Airport, Occidental Mindoro. was monitored by selected EMS personnel. No air craft were present during the monitoring. There was no illegal forest activity after 24 hours of duty and monitoring.


Monitoring of Abra de Ilog sea port located at Barangay Lumangbayan, Abra de Ilog, Occidental Mindoro was conducted by selected EMS personnel of DENR-CENRO Sablayan last June 9, 2023. All vehicles and sea vessel (motorized banca) including RORO shipping lines bound to Puerto Galera and Batangas City were searched and checked to ensure that there was no illegal forest activity will emerge. After 24 hours of duty and monitoring, there is illegal activity encountered.

Last June 16, 2023, selected EMS personnel conducted monitoring of Sablayan sea port located at Barangay Poblacion of the said Municipality. Every suspected vehicle and vessel was inspected. After 24 hours of duty, there were no illegal activity encountered during the monitoring.
