"WHEREAS, Bulalacao is a 3rd class municipality hounded with financial constraints located at the southernmost tip of the Province of Oriental Mindoro, has a population of 44,366 based on 2020 census, and has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;
