Respectfully submitted is the accomplishment report re; abovementioned subject within the area of responsibility of CENRO- Sablayan. The Conservation and Development Section spearhead the conduct of field work in response to the request of LGU Looc, Lubang and Sta. Cruz in assistance to the marine and coastal resources related concerns.

Please be informed in the following accomplishments related to the aforementioned target, to wit;

- a. **Mainstreaming of ICM to the CLUP of the LGUs within the major watershed** (river systems) contributing to the NIPAS MPAs.

Please be informed that the Sablayan Local Government Unit (LGU) held a Workshop on the Development of an Integrated Coastal Resource Management Plan (ICRMP) on May 07 - 08, 2023. This office was named to the Technical Assistance Team for the aforementioned workshop. Stakeholders and representatives from the Municipal and Barangay Fisheries and Aquatic Resources Council (FARMC), the Philippine Coast Guard, PNP Maritime, and LGU Offices such as the Municipal Planning and Development Council (MPDC), Municipal Agriculturists (OMA), Tourism (MTO), and Disaster and Risk Reduction Office (MDRRMO) were present. The plan will be incorporated into the LGU's Comprehensive Land Use Plan thanks to the efforts of the University of the Philippines - School of Urban and Regional Planning, which will assist in the creation of the plan.

The technical working committee presented the data requested by the University of the Philippines - School of Urban and Regional Planning, which will write the ICM Plan, at the meeting. The signatory has guaranteed that the watersheds (major and community) will be incorporated in LGU Sablayan's conservation and development plan.

Prior to the workshop, the undersigned together with CENRO Anastacio A. Santos attended in the preparatory meeting held at Balud Hall, 3rd Floor, LGU Compound in Sablayan, Occidental Mindoro on May 04, 2023. Also, the composite team conducted a field inspection and Key Informant Interview in the coastal communities of Brgy Burgos and Ligaya, obtaining preliminary and critical information that will be useful in the management planning process, such as monthly and annual fish catch data and other fisheries sector issues and concerns.

- b. **TA to LGUs on coastal and marine related concerns** (assessment., emergency response, facilitation, citizen science, validation, investigation of reports/ complaints etc.)

The CENRO Sablayan offered the following technical assistance to the LGUs, as evidenced by complete staff work reports:

1. Grounding incident of M/V ALISON V Cargo Ship in Looc, Occidental Mindoro

Based on the request of the Municipal Mayor Marlon V. Dela Torre of LGU Looc, Occidental Mindoro to the Office of the CENR Officer dated March 9, 2023 seeking assistance for the damage assessment on corals due to ship grounding of M/V Alison V Cargo Ship, this office provide technical assistance thru an assessment of the composite team created thereof.

Based on the conducted activities and investigation reflected in the Complete Staff Work by the composite team, the vessel M/V Alison V has been removed from the grounded area on December 06, 2022. The corals species damaged were *Porites spp.* (stony corals), *Acropora spp.*, such table/branching species. The Estimated Compensated Area of Damage (CAD) is **20,817 sq.m.**

2. Grounding Incident of MV Marfel V in Lubang, Occidental Mindoro

This office also provided technical assistance to the request of the Municipal Mayor Michael L. Orayani of LGU Lubang to the DENR MIMAROPA Region dated March 7, 2023 for the possible oil spill and damage assessment on corals due to ship grounding of MV Manfel V.

The total damaged area of corals were **4,751.31** square meters caused by the ship, grounded within the 277.11 meters distance from the shore. The corals species damaged were *Porites spp.* (stony corals), *Acropora spp.* (table/branching) and Soft Corals species and during the assessment, no indication of oil spill was observed in the vicinity of the grounded ship. However, the possibilities of oil spill may occur if the ship is not remove immediately.


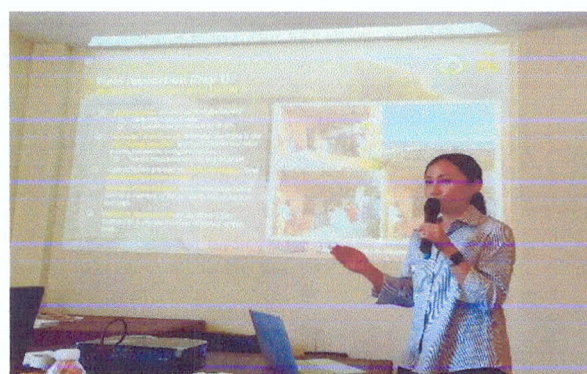
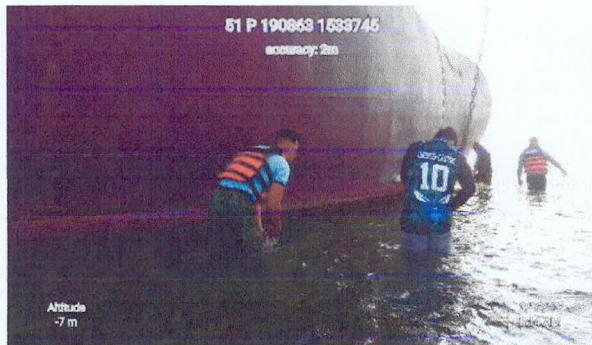
