A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO SIGN AND EXECUTE, FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF ROMBLON, THE MEMORANDUM OF PARTNERSHIP AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) RELATIVE TO THE IMPLEMENTATION OF THE PUBLIC LAND TITLING THROUGH THE RAPID LAND TENURE APPRAISAL.

WHEREAS, the Municipal Government of Romblon is determined to intensify its land related services for the benefit of its constituents;

WHEREAS, the Municipal Government of Romblon is fully cognizant of the vital importance of establishing a partnership with the DENR to increase its capacity in land administration and management;

WHEREAS, the DENR acknowledges the role of the LGUs in contributing to the effective development, administration and management of the country's land resources;

WHEREAS, the DENR is committed to creative, active collaboration with the LGUs for the improvement of the of land sector through the Rapid Land Tenure Appraisal;

WHEREAS, the DENR recognizes the indispensable assistance of the Municipal Government of Romblon in land administration and management;

WHEREAS, the Municipal Government of Romblon and the DENR agree to be bound in partnership towards a common goal of providing efficient land related services to the people; Now therefore, after due scrutiny and deliberations on the matter, and on motion duly seconded, be it –

RESOLVED, as it is hereby resolved to **AUTHORIZE** the Municipal Mayor, Atty. Gerard S. Montojo, to sign and execute the Memorandum of Partnership of Agreement with the Department of Environment and Natural Resources, copy of which is hereto attached and made an integral part hereof, relative to the implementation of the **Public Land Titling through the Rapid Land Tenure Appraisal**;

RESOLVED FURTHER, to furnish copies of this Resolution to the Honorable Mayor, Atty. Gerard S. Montojo; the Honorable Regional Director Henry A. Adornado, DENR MIMAROPA Regional Office; and the Municipal Assessor, Engr. Theodore M. Rojas; for their respective information and appropriate action.
