(LAMS) OF DENR-CENRO SABLAYAN

This is to respectfully inform your office regarding the current status of Land Applications Management System (LAMS) of DENR-CENRO Sablayan, Occidental Mindoro.

Due to the unstable power supply of the Province of Occidental Mindoro during the previous months, the desktop computer intended for LAMS has bugged-down and we cannot retrieve any back-up file. That despite the exerted effort to repair the problem, we are not able to fix it and remained unserviceable. The office is currently in need of the information from the system to address the concerns on the conducted Rapid Land Tenure Assessment activities as well as the ongoing implementation of the online public land application.

May we also inform you that during the actual visit of the DENR-MIMAROPA Regional Team for LAMS-PLA inventory and system verification headed by Engr. Marianne P. Doblado, Engineer II/System Admin sometime in the third quarter of 2022, it was found out that they only activity conducted during the previous administration was capturing of images of carpetas and no respective data was encoded. Hence, the current designated In-Charge of Records Unit will definitely begin from scratch. This office would like to cope with the ongoing implementation of LAMS-PLA as compliance for the crucial target of our agency.

With this, we would like to request for the assistance for the Regional Office as regards to the ICT equipments intended for this activity and back-up file of LAMS-PLA data if there's any covering the municipalities of Mamburao, Sta. Cruz, Paluan, Abra de Ilog, Looc and Lubang as part of the administrative jurisdiction of CENRO Sablayan. The mentioned municipalities are the affected areas of the lost data of LAMS-PLA.
