Finding merit, the motion is hereby GRANTED. The OGCC is given time until May 1, 2023 to file its Position Paper.


The Entry of Appearance of the OGCC is hereby NOTED. All subsequent orders, notices and other court processes relative to this case should be served to the above named counsel at his given address .
