



IMPLEMENTATION WITHIN THE ADMINISTRATIVE JURISDICTION

OF CENRO SAN JOSE, OCCIDENTAL MINDORO

Respectfully submitting is the activity report on the implementation of Cave Management Plans of Purnaga/Taboy-Taboy Cave, Alibog Cave and Lagoon and Catburan Cave located within the municipalities of San Jose and Magsaysay, Occidental Mindoro with MFO 310201100001000.

The CDS-BMU team composed of ECOMS II Ma. Teresita P. David, Jr., Forest Technician I Niño Aloysius B. Colegado and Support Staff Vergel L. Encado conducted coordination with LGU of Magsaysay thru MPD Officer Don Vincent B. Busto on May 3, 2023 regarding cave-related targets of DENR CENRO San Jose in the municipality of Magsaysay such follows: (1) Implementation of the Management Plans of Taboy-Taboy/Purnaga Cave and Alibog Cave and Lagoon; and (2) Identification of cave/s for assessment and classification and the proposed activities relative to these targets. Nevertheless, a meeting was scheduled on May 12, 2023 (8:00 AM) together with the stakeholders of the two caves.

Also, the team conducted coordination with *Punong Barangay* June S. Palmares and some officials of Barangay Batasan on May 5, 2023 regarding the upcoming activities related to the implementation of Catburan Cave Management Plan specifically the activities under the 1<sup>st</sup> year stipulated in the plan. In fact, during the coordination both parties agreed to have a meeting together with LGU of San Jose specifically the representatives from Municipal Environment and Natural Resources Office (MENRO), Municipal Tourism Office (MTO), Municipal Planning and Development Office (MPDO) and other stakeholders. The said meeting was scheduled on May 23, 2023 (9:00 AM) to be held at the Multi-Purpose Hall of Barangay Batasan, San Jose, Occidental Mindoro.

The agendas of the meetings for the mentioned caves are as follows;

- 1. Creation of Cave Committee for each cave,
- 2. Implementation of Action Plan (focusing on the activities under the Year I)
- 3. Implementation Scheme (Organizational Structure of Cave Management Plan Implementing and Monitoring Body); and
- 4. Other cave related matters (Issues and Concerns).

In furtherance, based on the adopted Management Plans of the three (3) caves and to strengthen the protection and conservation of cave resources, the stakeholders will be planting in digenous forest trees, fruit trees and bamboo with the technical assistance from the DENR. In order to accomplish the specific activity within the time frame, the CDS BMU conducted an ocular site inspection in the central nursery of DENR
