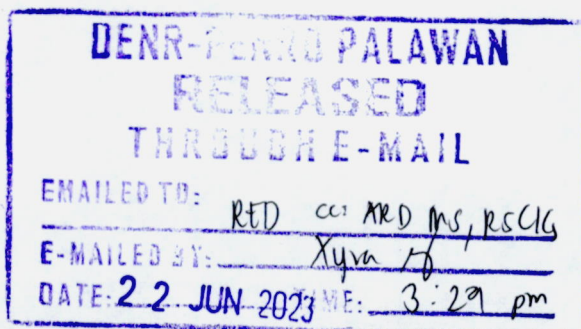





Then, the undersigned have briefly discussed about time span degradation of different types of solid wastes mostly collected during clean up drives.

A more or less 47 sacks of garbage consist of fishing lines, disposable spoon and fork, plastic sachets of basic consumables items for cooking, bottles, rag clothes and woods were collected by 73 individuals (36 Masculine and 37 Feminine) from DENR CENRO Coron, Philippine Coast Guard, Philippine National Police Municipal Station and Maritime Group, Solid Waste Management Office and volunteers from Brgy. Poblacion 5, Coron, Palawan.

Several piles of garbage were observed along the coastline of the reclamation came from tourist boat operators given that solid waste congregated are packaging of condiments, paper plates, disposable utensils and leftover foods. Also observe are scattered woods and cans of paint, used oils obviously from the locals labouring their boats in the area. All boats docking in the area were reminded regarding their solid wastes and advised to report those boat operators dumping their garbage properly.

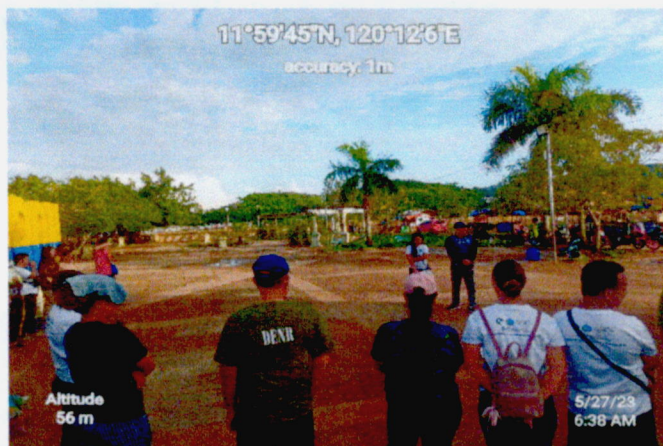
