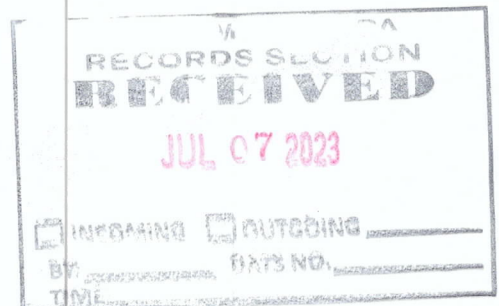

CRUZ AND BARANGAY SALVACION).

WHEREASL Article II, section 5 of the Philippines Constitution provides, that: "the maintenance of peace and order, the protection to life, liberty and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessing of democracy",

WHEREAS; Article XII, Section 1 of the same Constitution provided, that: "The goal of the national economy are more equitable distribution of opportunities, income and wealth; a sustained increase in the amount of goods and services produce by the nation for the benefit of the people; and an expanding productivity as the key to raising the quality of life for all, specially the under privileged",


Records show that lot 13482 and 13520, Cad. 800-D, Puerto Princesa Cadastre registered in the name of Arthur Millare, et al containing total area of Four Million Eighty Nine Thousand Three Hundred Twenty Four and Fifty Seven (4,089,324.57) square meters located in Salvacion, Puerto Princesa, Palawan was surveyed by Engineer Abel Orias into one hundred (100) lots and submitted in this office for verification and approval under Ccs-04-002222-D and was consequently approved on July 3, 2001. The subject area is within the coverage of Proclamation No. 2282 "Reclassifying certain portion of the public domain as Agricultural Land and Settlement purposes of the Kilusang Kabuhayang at Kaunlaran (KKK) and Resource Management Program of the Ministry of Human Settlement".

In a memorandum by the OIC, Regional Technical Director for Lands, Lydia S. Lopez addressed to the Regional Executive Director, Marcial C. Amaro, Jr. dated February 18, 2009 recommended the cancellation of CCS-04-002222-D since the area is within timberland as certified by NAMRIA on 24 February 1998. The recommendation is in pursuance to Presidential Memorandum Order No. 10 clarifying that alienable and disposable (A and D) lands prior to Proclamation No. 2282 shall remain A and D shall be turned over to Department of Agrarian Reform (DAR) for disposition. The said memorandum was silent in the reclassification of timberland into Alienable and Disposable Lands under Proclamation No. 2282.

Please refer to the attached Completed Staff Work (CSW) recommending cancellation of the said plan as approved by the Regional Executive Director dated February 13, 2009.

WHEREFORE, the foregoing premises considered plan, Ccs-04-002222-D together with its accompanying survey returns and other documents related thereto is hereby CANCELLED.
