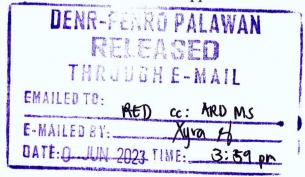
Please be informed that the travel is purely official and in compliance to DENR Special Order No. 2023-158.
