Forwarded is the Memorandum dated April 5, 2023 of PENRO Palawan regarding the grounding incidents of two vessels in Tubbataha Reef Natural Park (TRNP).

Per report, M/Y Resolute and M/Y Stella Maris Explorer run aground last March 27 and 28, 2023. As a result, M/Y Resolute damaged a total of 133.36 square meters of corals while M/Y Stella Maris Explorer caused 79.6 meters of damaged corals, respectively.

The TMO-PAMO is in the process of building an administrative case against the two offenders before Tubbataha Adjudication Board and filed two cases for violation of Chapter 4, Rule 21 (Damage to the Reef) under the Republic Act No. 10067 known as the TRNP Act. This provides the legal and institutional framework for enforcement in the TRNP.

On April 4, 2023, an EXECOM meeting was conducted regarding the two grounding incidents with a decision that TMO-PAMO PASu Angelique Songco will coordinate with the DENR PENRO and PCSDS Legal to prepare the necessary document to support for the filing of the case.

Attached is the grounding incident report together with photo documentation.

Respectfully submitted is the report on the conducted Performance Evaluation of the five (5) SIFMAs located in Barangay Sihi, Municipality of Buenavista, Marinduque.

RATIONALE/BACKGROUNDER:

Pursuant to Executive Order No. 192 dated June 10, 1987, the DENR is empowered to exercise supervision and control over the forestlands of the Philippines. Whereas, Section 34 of PD 705, as amended states that a lease for fifty (50) years for the establishment of an industrial tree plantation, tree farm, or agro-forestry farm, may be granted by the Department Head, upon recommendation of the Director, to any person qualified to develop and exploit natural resources, over timber or forest lands of the public domain. Further, Section 44 provides the visitorial power/authority to conduct an ocular inspection and examine records/documents relating to the operation of a holder of the license agreement to determine compliance with the terms and conditions to serve as the basis for the renewal or non-renewal thereof. Hence, a composite team of the Regional Office-Enforcement Division and PENRO Marinduque personnel conducted a Performance Evaluation of the agreement granted and entered into by the DENR and a private entity.

METHODOLOGY:

Prior to the travel date, the Enforcement Division team informed the PENRO-Marinduque regarding the activity to be conducted in their area of jurisdiction. The team together with PENRO Monitoring and Enforcement Section personnel proceeded to Barangay Sihi, Buenavista, Marinduque where the five (5) SIFMAs are located. An interview was conducted at the Barangay Hall of Sihi, Buenavista, Marinduque, with the SIFMA holders and the heirs of the deceased SIFMA holders.

He presented violations and hotspots maps of apprehensions from 2017 to 2021, based on LAWIN, LGU, and Protect Wildlife WEO information. The digitized map showed by Atty. Lorenzo revealed records of threats inside the core zone of MMPL. It was also showed that there's no patrolling done in Quezon and Rizal. Atty. Lorenzo presented images particularly on the observed threats in the area such as road construction in Quezon, improper waste disposal in Rizal, wildlife trafficking in Brgy. Iraan, mining in Brgy. Maasin, and remnants of trees that has been cut in Brgy. Calasaguen. 		 It was recommended by Mr. Arnel C. Gamutia of PENRO CDS to establish green barrier at MMPL. Mr. Anecito Ayala of LGU Quezon moved for the endorsement of the proposal and it was seconded by Mr. Valentino Palasague of LGU Bataraza.
