
AGRICULTURAL FREE PATENT APPLICATION

This pertains to your memorandum dated May 10, 2023 returning the twenty-six (26) carpeta of the Public Land Applications covering lots within the jurisdiction of the CENRO Coron, Palawan. The same is returned to comply with the lacking requirements and submit compliance to the following instructions to wit:

- 1. To verify/validate, re-assess and conduct ground verification if the applicant/heir/s is/are still interested and to provide necessary assistance;
- 2. To facilitate the submission of an update on whether or not the corresponding title has been issued.

Per evaluation we made of each of the carpeta, the following are the observations with justifications leading to considerations:

- 1. That there is no single checklist attached to justify the lacking requirements subject of our compliance;
- 2. That all areas covered by the applications are more than five (5) hectares. All issuances/guidelines inform that more than 5 hectares is within the authority of the Regional Executive Director to approve. Thus, there is no point in issuing the same without the intervention of the Regional Executive Director;
- 3. That we cannot urgently comply with the instruction as to the validation considering that we lack the manpower to attend and have no fund allocation to incur the expenses for inspections.



4. That all judicial forms attached conform to the old guidelines. Considering the issuance of RA 11573, we are seeking opinion on whether the same is still eligible to be used leading for issuance and or approval.
