In compliance to the instruction of Protected Area Superintendent (PASu) Mildred A. Suza to attend the meeting. Please be informed that the undersigned attended meeting regarding on the above subject on April 4, 2023 at Municipal Conference Hall.

The said meeting was spearheaded by Municipal Mayor Edna Gacot Lim. During meeting, the council presented the details, discussed the open solution to raise concerns and required action, documentation and reporting of all efforts in each implementation phases. Assessment of the Benchmarking activity and proposed plan of actions addressing the health and environment concerns of Bacuit Bay, El Nido, Palawan was also presented wherein the DENR-Protected Area Management Office (PAMO) assigned the following with other department.

1. **Strict monitoring of Establishment and Environmental quality** such as; Creation and full activation of a multi-agency El Nido Rehabilitation Task Force (ENRTF), 100% periodic water quality testing and facility check of water providers, water refilling stations, tourism establishments, and shallow & deep wells, detection and removal of underground sewerage discharge pipes; imposition of penalties to perpetrators, monthly collection and monitoring of water quality in 4 esteros and 21 tourism destination swimming areas (every 1st week of the month sampling)
2. **Intensify Policy Implementation and compliance** Operationalization of El Nido DENR – EMB Water Quality Laboratory (in NIPAP building) thru DENR-EMB.
3. **Installation/Construction of related facilities** such as Construction of eco-toilets in 5 key beaches in Bacuit Bay, Pasandigan, Snake Island, Talisay, Entalula and Shimizu Island.
4. **Aggressive Education and awareness campaign** Installation of signages for public awareness on Bacuit Bay water quality e.g. “No Swimming Zone”; “tap water not fit for drinking” etc., House-to-house information drive on Bacuit Bay water quality condition and periodic information on ENRTF (EN Rehab Task Force) activities and Continuing public education through community meetings and clean-up drives.

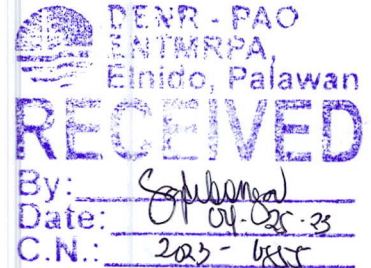

The meeting focus on the highlight of the PCSD approved SWM Plan 2019-2029 Source Reduction Initiatives, Collection and transfer and processing of Biodegradable and Recyclable wastes. Current garbage collection also presented wherein the MENRO only have one (1) garbage compactor, one (1) Dumptruck 4T capacity and one (1) Dumptruck of 2T capacity, 2-3 trips every morning and half day collection on during Sundays.

Further, update on 2023 pipeline interventions/activities such as Procurement of one (1) unit small garbage compactor, repair and maintenance of equipment and machineries in SLF, Procurement of mobile trash bins, Procurement of lot for new SLF, Municipal wide IEC thru GAD, Meet and organize private garbage collectors and request for additional funding and Tapat ko Linis ko re-launching was also discussed. The meeting was ended at 3: 40 in the afternoon.
