Respectfully forwarded is the memorandum of CENRO Quezon, Palawan dated April 12, 2023 relative to the above subject.

Per memorandum, the apprehension was made on February 23, 2023 at around 10:20 A.M. regarding the reported alleged illegal cutting of naturally grown trees in Sitio Kalatabog, Barangay Panitian, Quezon, Palawan. The CENRO personnel together with the Bantay Quezon and PNP Maritime conducted the said operation, upon arriving the place there is no person/claimant found or caught in the area.


The apprehended undocumented lumber of Apitong, Talisay Gubat and Sagosahis species has a total of 343 board feet with an estimated fair market value of Php12,005.00. The apprehended lumber were brought to the compound of DENR-CENRO Quezon, Palawan for safekeeping purposes.

Three (3) notices to the public were posted in different public places dated March 07, 2023, March 20, 2023 and March 30, 2023. However, no claimant appeared in the CENR Office which the apprehended lumber will be forfeited in relation to section 8 of DAO 97-32. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their rights to the items apprehended in favor of the government.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended lumber.

Submitted herewith is the summary of the Administrative Confiscation proceedings together with pertinent documents anent the above-cited subject treated under DAO 97-32.

I. FACTS OF CASE

WHAT : Apprehension of Forty One (41) pieces of Apitong, Talisay Gubat and Sagosahis lumbers having a total volume of 343 board feet with an estimated fair market value of Php 12,005.00.

WHEN : On or about 10:20 AM of February 23, 2023

WHO : No Claimant/Abandoned

WHERE : Sitio Kalatabog, Barangay Panitian, Quezon, Palawan

HOW : On February 23, 2023, the CENRO Enforcement personnel together with the Bantay Quezon and PNP Maritime conducted verification regarding the reported alleged illegal cutting of naturally grown trees at Sitio Kalatabog, Barangay Panitian, Quezon, Palawan and upon arrival in the specific location, The team discovered fresh cut 41 pieces of Apitong, Talisay Gubat and Sagosahis lumbers having a total volume of 343 board feet. Per on-site investigation no person/claimant found in the area, hence, declared abandoned. The apprehended lumbers were brought to DENR-CENRO Quezon compound, Quezon, Palawan for safekeeping under the custody of FT.I Jesse O Cascara. Subsequently, a Seizure Receipt and Seizure Order dated March 09, 2023 were issued by the undersigned.

II. NOTICE TO THE PUBLIC FOR THE CONDUCT OF HEARING:

Pursuant to the provision of Department Administrative Order No. 97-32 Re: Rules for Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyances used in connection therewith specifically Section 08, item No. 3, posting of notice to the public for the conduct of administrative hearing for Three (3) consecutive weeks at the different conspicuous place of Quezon, Palawan was conducted by this Office.

III. FINDING/EVALUATION:

In spite of the Three (3) consecutive notices posted however, no claimant appeared before this Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their right to the items apprehended in favor of the government.

IV. APPLICABLE LAWS:

Department Administrative Order No. 97-32 Section 8, item No. 3, Notice of Hearing shall be posted at least Three (3) public places, including, but not limited to: (a) the Barangay Hall of the apprehension site; (b) the Bulletin Board of the DENR Offices where the proceedings will be conducted, and (c) at the Municipal Hall of the apprehension site.

V. RECOMMENDATION

In view hereof, it is recommended that the Forty- One (41) pieces of Apitong, Talisay Gubat and Sagosahis lumbers having a total volume of 343 board feet with an estimated market value of Php 12,005.00 apprehended at Sitio Kalatabog, Barangay Panitian, Quezon, Palawan be confiscated in favor of the government.



The team conducted investigation but we failed to gather any information of the identification of the culprits.

The said forest products were apprehended in violation of Section 77 of PD 705 as amended and impounded at DENR CENRO Quezon compound for safekeeping.
