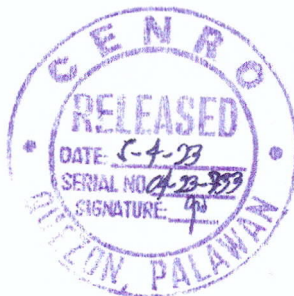

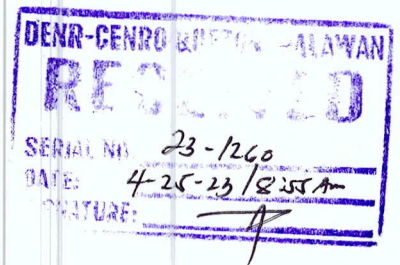

HIGHLIGHTS

Lionheart Farms (Philippines) Corporation (LFPC) seeks to conserve the remaining forest through protection, reforestation of denuded areas, assisted natural regeneration (ANR) of the remaining forest, and secure the protection and maintenance of planted trees.

The Forest Protection project also aims to achieve the following:

- (1) Compliance with the JVA requirements;
- (2) Strengthening existing collaboration(s) with the MENRO, PCSD, DENR, Municipal LGU, and Local Government Units (LGU) of Ransang and Candawaga, Rizal and other local communities and partners primarily with the protection and reforestation of the denuded forest;
- (3) Supporting the National Greening Program of the Government (NGP);
- (4) Further enhancement of the awareness and capabilities of the local communities in the protection, and reforestation of denuded forests and establishment of endemic fruits & trees, and high-value fruit tree plantation;
- (5) Effective mobilization of local communities towards the protection of the remaining forest and establishment of high-value fruit tree plantation; and
- (6) help improve the living condition of IPs and non-IPs through the promotion of raising indigenous tree and fruit tree seedlings.



For March 2023, the Lionheart Farms (Philippines) Corporation (LFPC) has accomplished the following activities:

- A. Last March 2023, Lionheart Farms (Philippines) Corporation (LFPC) the land negotiation team conducted an Information Education Campaign (IEC) in Sitio Maruso, Dinakpan, Ransang, and Maruso, Candawaga Rizal, Palawan. The team explained to the participants the proposed bamboo plantation in the denuded areas and area not passed to coconut plantation standard, benefits of bamboo in the next future like the sources of ladder for coconut sap harvesting of Lionheart company, carbon sequestration and protection of the river bank. The activities were participated by the local community of Brgy. Ransang and Candawaga, Rizal, Palawan. ***(Please see photos attached as ANNEX A)***
- B. Last March 2023, Lionheart Farms (Philippines) Corporation (LFPC) Foot Patrol Unit continued conducting onsite-regular monitoring of illegal activities inside the Joint Venture Agreement (JVA) and bordering/adjacent areas of JVA. As of March, based on the report by the Foot Patrol Unit. The team roamed and observed the areas fortunately, there is no trace/mark of illegal activities such as illegal logging, timber smuggling, illegal trade of non-wood forest products, poachers of wildlife, illegal sale of wildlife in the markets/illegal transport of wildlife as well as kaingin practices and production of charcoal in the farms monitored in the approved areas of Agroforestry Development Project (AFDP) that are because of the presence of CENRO, KSK, Barangay and also the foot patrol monitoring team of Lionheart Farms (Philippines) Corporation (LFPC). ***(Please see photos attached as ANNEX B)***
- C. Last March 2023, Lionheart Farms (Philippines) Corporation (LFPC) planter workers continued conducting a plantation care, protection and maintenance specifically in Barngay Ransang, Rizal, Palawan. The following activities undertaken are stirp brushing, round weeding, application of bio-organic fertilizer and replanting of seedlings mortality. ***(Please see photos attached as ANNEX C)***




- D. Last March 2023, Lionheart Farms (Philippines) Corporation (LFPC) nursery caretaker continued conducting nursery activities such as watering of seedlings regularly, weeding around the seedlings, spraying of organic pesticide and fertilizer once a month and also at the end of the month the nursery worker conducted an inventory to monitor/evaluate the number of seedlings stocks. Sorting of seedlings were done. The total seedlings stocks are Fifteen thousand seven hundred fifty-four (15,754) seedlings. ***(Please see photos attached as ANNEX D)***

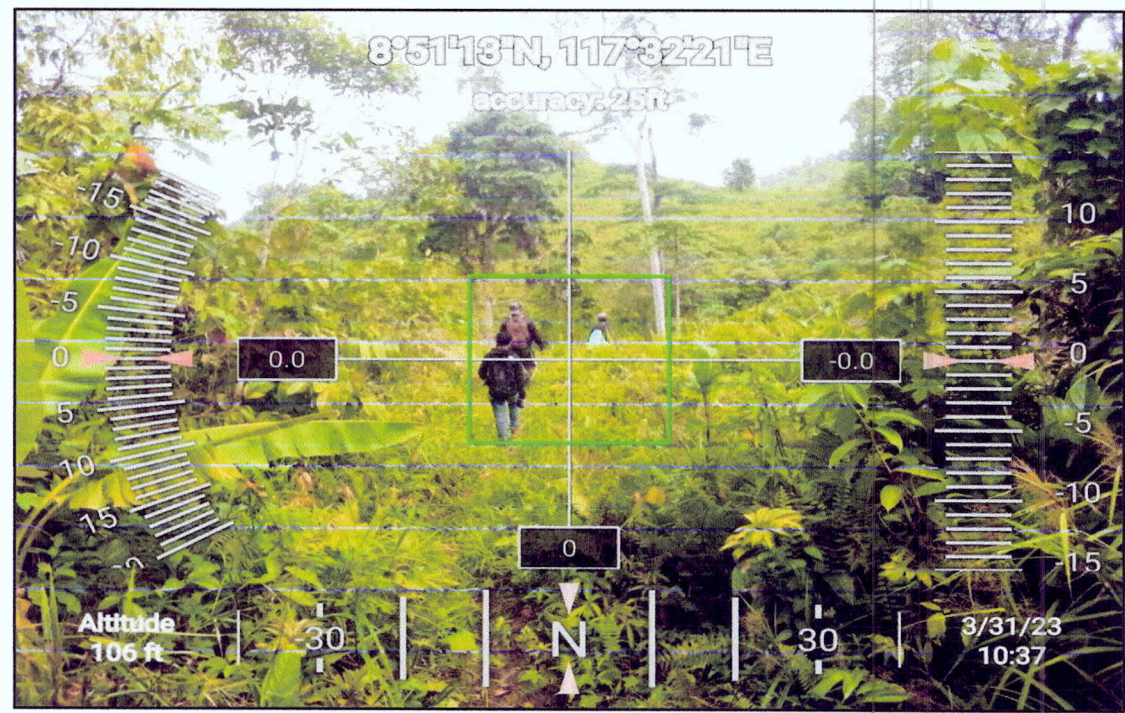

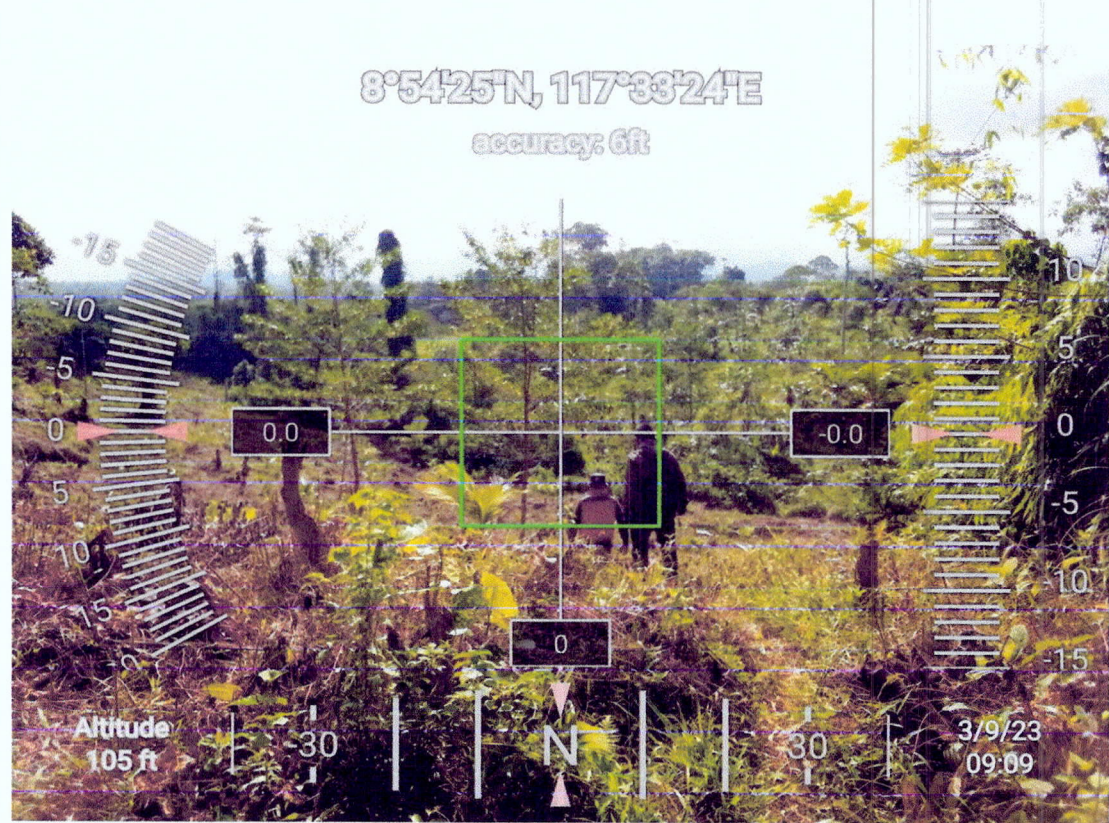

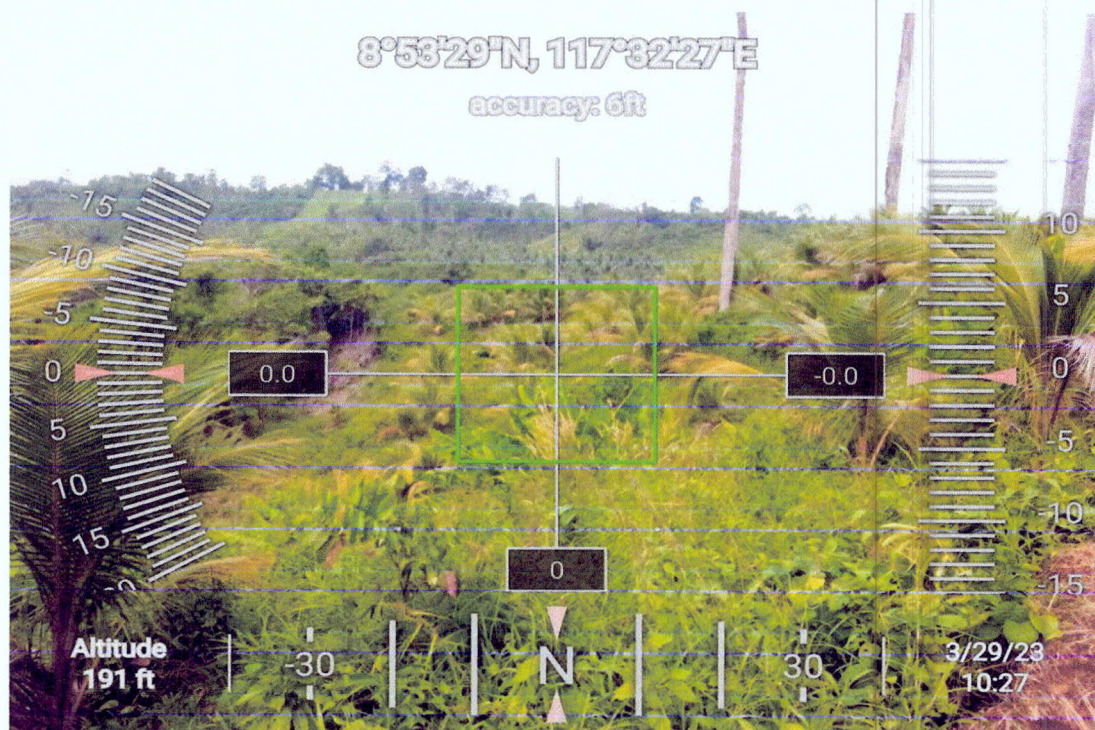
