

BMS was conducted using four (4) main methods: Focus Group Discussion (FGD), Field Diary, Photo Documentation and Transect Walk.

1. FOCUS GROUP DISCUSSION (FGD)

FGD was conducted on February 16, 2023 in Harrison, Paluan Occidental Mindoro. It was participated by the Community Monitoring Group (CMG) from Sitio Ulasan and So. Hinugasan. During the CMG meeting, the main issues discussed were populations of Mindoro Warty pigs and monkeys. These species are both increasing in number, thus become a threat and pest to their crops.

2. FIELD DIARY

Below are the priority monitoring species recorded using Field Diary in Mount Calavite Wildlife Sanctuary (MCWS) for the first semester CY 2023.





This Office concurs with the draft guidelines as it follows the DENR Administrative Order No. 2021-13 or the "Guidelines for the Development and Recognition of Biodiversity-Friendly Enterprises (BDFE) in Protected Areas under the National Integrated Protected Area System (NIPAS) and Conservation Areas, Providing for Incentives and Supporting Mechanisms."

Further, hereunder are our comments/recommendations based on our experience within MIMAROPA Region on the process of completion of requirements for BDFE Proposals:

- 1. The list of requirements, particularly the BDFE Business Plan, are highly technical and may need a lot of time to be prepared. Please be informed that our Peoples Organizations (POs) within the region need more time and resources to understand the processes and complete the requirements needed. Hence, may we request that the list of requirements be reconstructed into a simpler format, such as the Annex H: Proposal Outline of DAO 2021-13 which contains the simple project brief and the Work and Financial Plan (WFP) as main requirements for the proposal;
- 2. DAO 2021-13 Section 13.4. Roles and Responsibilities of the Protected Area Management Office (PAMO)/Community Environment and Natural Resources Office (CENRO) states that "The PAMO and CENRO shall have additional staff, skilled at business development to provide support to BDFEs." The PAMO staffs are being trained continuously on skills development related to BDFE,

As determined by our evaluation, we would like to bring to your attention the following findings and observations:

1. The 4th Quarter CY 2022 maintenance work that were conducted/finished and reported per Memorandum dated December 12, 2022 are almost same as those reported on the 1st Quarter CY 2023 report per Memorandum dated March 10, 2023.

It is noted that MWS-PAMO is maintaining the same set of facilities and infrastructures. However, it appears that maintenance works like repair, repainting, renovation, and other improvements that were already finished or completed in the fourth quarter of CY 2022 are once again carried out in the first quarter of CY 2023. Please rectify/update the status as needed or provide clarification whether maintenance activities are being continued or completed.

2. The columns "Total Cost" and "Date of Completion" in the attached Table from your 1st Quarter CY 2023 report contain some incorrect data or information. Between the two columns, it seems as though that some data have been interchange.

Additionally, some details entered under "Maintenance Work Conducted" appear to belong more appropriately under the "Remarks" column (e.g. for repair, damaged by typhoon, newly installed).

Be reminded of our Memorandum dated July 28, 2022 instruction for you to include on your table/matrix per particulars the specific maintenance/protection activities conducted. Hence, we kindly request that you review your submitted report and make the necessary corrections.



Per report from the Special Collecting Officer of the Naujan Lake National Park-Protected Area Management Office (NLNP-PAMO), a total amount of fifty-two thousand, four hundred and twenty pesos (₱52,420.00) was collected from January 2023 to March 10, 2023, from fishing permit fees of fisherfolks, PA entrance fees, and other fees (video/photo documentation).

Seventy-five percent (75%) of the total collection or thirty-nine thousand, three hundred and fifteen pesos (₱39,315.00) was deposited to the IPAF-Retained Income Account (IPAF-RIA), while twenty-five percent (25%), or thirteen thousand, one hundred and five pesos (₱13,105.00) was remitted to the IPAF-Special Account in the General Fund (IPAF-SAGF) through the Landbank of the Philippines, Calapan.

This refers to one of the agreements reached during the Learning Event on Human Resource Systems held last 08-11 November 2022 in the Province of Palawan. It was agreed that there is a necessity to review and revise the current SRP of the field offices, and this will be carried out early CY2023.

It may be recalled that last year, the MSD Chief of PENRO Occidental Mindoro, refused to sign the screening and deliberation documents for the posted vacant positions of DENR Occidental Mindoro because of the learnings he gained from the above-cited Learning Event. Specifically, he cited the need to amend/update the System of Ranking Position (SRP) of the region and to defer and immediately schedule the updating of the region's SRP before completing the ongoing hiring and promotion. He believed that the current SRP deprived several personnel equal opportunity to apply for vacant positions in the province. Copy of the letter is attached for your reference.

In view of this, we feel that we can no longer wait for the nationwide conduct of the review and amendment of the SRP. Hence, we would like to request for Resource Person/s from your office to facilitate and guide us in the review and amendment of the DENR-MIMAROPA SRP for us to proceed with the filling up of vacant positions, particularly in the Province of Occidental Mindoro.
