## **MOTION FOR PARTIAL RECONSIDERATION**

The Movant ORLANDO BADUA, unto this Honorable Office most respectfully states that:

- 1. In an order dated January 15, 2020, this Honorable Office ordered the confiscation of the apprehended PUV with Temporary Plate No. 046005 which is registered under the name of herein Movant.
- 2. The Movant was not informed of the said decision and it was only the time when he inquired at DENR-CENRO Brooke's Point, Palawan that he learned of the said decision. It was only in March 2023 when the case pending before the MCTC of Brooke's Point was dismissed, he went to DENR-CENRO Brooke's Point and the latter informed him that there was an Order of Confiscation. That the Movant did not receive the subject Order from this Honorable Office.
- 3. The Movant moves for the reconsideration of the order of confiscation on the ground that there was no factual basis and evidence to support the confiscation. That it did not cite any specific evidence to support the Order of Confiscation. Substantial evidence shall suffice to sustain an administrative Decision adverse to interested party but in this case there was no mentioned of that substantial evidence which was used as basis to sustain the Order of Confiscation.
- 4. During the so-called Administrative Hearing which the Movant did not know as such. He was not informed of his right to counsel. They were not also given an opportunity to submit a Memorandum or to submit Affidavits and any other supporting documents thereto. The Movant already stated that he has no personal knowledge on the transactions made by his driver which was also corroborated by his driver who admitted that it was Dernalyn Mauddin who approached the driver to load and deliver the same to Brooke's Point, Palawan. Mr. Romy Vejano, the driver also admitted that the Movant has no personal knowledge that his PUV will transport charcoals because the same is used to carry passengers only. Copy of the Sinumpaang Salaysay of Romy R. Vejano is hereto attached as **Annex "1"**.
- 5. Despite the Movant's non-knowledge that his PUV was used to carry charcoals, still his PUV was confiscated. That it would be very unjust for the Movant, that his hard-earned money in purchasing the said PUV will be gone because it was forfeited in favor of the Government even though he had no knowledge or consent in transporting the said charcoals.

WHEREFORE, it is respectfully prayed unto this Honorable Court to reconsider its Order of confiscation of one (1) unit PUBLIC UTILITY VEHICLE (PUV) JEEPNEY WITH TEMPORARY PLATE NO. 046005 and to release the same to herein Movant.
