**O R D E R**

This case was called for hearing on the Motion to Release Vehicle. Atty. Frances Margarette Mendoza appeared for the DENR and Atty. Marie Grace Trinidad of the Public Attorney's Office. Record shows that the court already dismissed this case per order dated November 25, 2021 on the ground that charcoal is not a forest product per definition of PD 705 and directed the DENR for the release the motor vehicle. However, the agency refused to release the motor vehicle. The DENR manifested that the agency may release temporarily the vehicle upon posting of the cash bond.

It is clear under the law that charcoal is not a part of forest product and there is no basis for the DENR to pursue with the administrative case against the accused.

Wherefore, the motion is hereby granted. The DENR is directed for the immediate release of the motor vehicle within 48 hours upon receipt of this order.

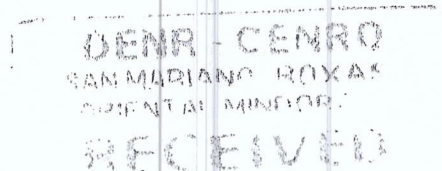

ORDER

This case was called for arraignment and pre-trial. Accused was indicted for violation of PRESIDENTIAL DECREE NO. 705 also known as REVISED FORESTRY CODE OF THE PHILIPPINES that was allegedly committed on 24 October 2021 at Brgy. Poblacion, Mansalay, Oriental Mindoro. Accused through counsel moved to quash the Information on the ground that the facts charged do not constitute an offense as charcoal is not a forest product.

Upon re-examination of the Information, as well as the sworn statements of witnesses, the prosecution has no reason to indict the accused for violation of PD No. 705 for possession of charcoal. Under sec. 77 of PD No. 705, it is unlawful to cut, gather, collect timber or other products without a license, to wit:

**"Section 77.** Cutting, gathering and/or collecting timber or other products without license. Any person who shall **cut, gather, collect, or remove** timber or **other forest products** from any forest land, or timber from alienable and disposable public lands, or from private lands, without any authority under a license agreement, lease, license or permit, shall be guilty of qualified theft as defined and punished under Articles 309 and 310 of the Revised Penal Code; Provided, That in the case of partnership, association or corporation, the officers who ordered the cutting, gathering or collecting shall be liable, and if such officers are aliens, they shall, in addition to the penalty, be deported without further proceedings on the part of the Commission on Immigration and Deportation.

The Court shall further order the confiscation in favor of the government, of the timber or forest products to cut, gathered, collected or removed, and the machinery, equipment, implements and tools used therein, and the forfeiture of his improvements in the area.

The same penalty plus cancellation of his license agreement, lease, license or permit and perpetual disqualification from acquiring any such privilege shall be imposed upon any licensee, lessee, or permittee who cuts timber from the licensed or leased area of another, without prejudice to whatever civil action the latter may bring against the offender."

While sec. 3 (q) of the same law defines forest product, to wit:

"(q) Forest product means timber, pulpwood, firewood, bark, tree top, resin, gum, wood, oil, honey, beeswax, nipa, rattan, or other forest growth such as grass, shrub, and flowering plant, the associated water, fish, game, scenic, historical, recreational and geologic resources in forest lands."

In sum, it is clear that it is prohibited to cut, gather, collect timber or other products without a license. The law itself defines forest products which, by its classification are raw, unprocessed or natural materials from forest. While the items subject of this case is charcoal, which is a hard-black material that is made by burning wood with a small amount of air, a processed product. This Court is guided by a well-acknowledged legal maxim "*expressio unius est exclusio alterius*". The Supreme Court held:

"It is settled rule of statutory construction that the express mention of one person, thing, act, or consequence excludes all others. This rule is expressed in the familiar maxim *expression unius est exclusio alterius*. Where a statute, by its terms, is expressly limited to certain matters, it may not, by interpretation or construction, be extended to others. The rule proceeds from the premise that the legislature would not have made specified enumerations in a statute had the intention been not to restrict its meaning and to confine its terms to those expressly mentioned (*Development Bank of the Philippines v. Commission on Audit*, G.R. No. 221706, 13 March 2018)."

It was also held that:

"The rule of *expressio unius est exclusio alterius* and its variations are canons of restrictive interpretation. They are based on the rules of logic and the natural

workings of the human mind. They are predicated upon one's own voluntary act and not upon that of others. They proceed from the premise that the legislature would not have made specified enumeration in a statute had the intention been not to restrict its meaning and confine its terms to those expressly mentioned (*Dela Salle Araneta University v. Bernardo*, G.R. No. 190809, 13 February 2017)."

Hence, charcoal is not included as forest product. The accused did not violate PD No. 705 and the case against him should be dismissed.

Besides, the charcoal in this case cannot be considered forest by-product. There is no proof that the charcoal subject of this case came from timber, lumber or fruit bearing tree. It is common within this jurisdiction that scaffoldings made from lumber and pieces of wood left-overs in construction sites were collected to be processed as charcoal. Therefore, this Court cast serious doubt to the source of charcoal in this case.


WHEREFORE, the facts charge does not constitute a violation of PRESIDENTIAL DECREE NO. 705 also known as the REVISED FORESTRY CODE OF THE PHILIPPINES, the motion to quash the Information is hereby GRANTED and the case against the accused is DISMISSED. Bail bond posted by accused under official receipt no. 4279306D amounting to ₱24,000 be released to the bondsman or duly authorized representative upon presentation of documents and availability of funds.

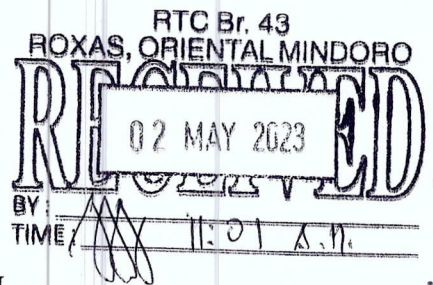

**MANIFESTATION**

**COMES NOW**, the Community Environment and Natural Resources Office – Roxas, Oriental Mindoro (CENRO) of the Department of Environment and Natural Resources Office (DENR), through the undersigned Property Custodian, and unto this Honorable Court, hereby respectfully manifests the following:

1. Last April 27, 2023, this Honorable Court made an Order in open court directing the immediate release of the subject vehicle within forty-eight (48) hours from the said Order.
2. While the said vehicle is still subject of an ongoing administrative proceeding, the CENRO through the undersigned herein expresses its intention to comply with the said Order. However, as of the filing of the instant Manifestation, the owner or his duly authorized representative has not yet come to the Office to claim the said vehicle. This is to humbly and respectfully inform the Honorable Court that the said vehicle cannot be released without the coordination of the owner or his duly authorized representative to ensure that the vehicle will be taken care of.
3. Thus, the undersigned humbly and respectfully informs this Honorable Court that the registered owner or his duly authorized




representative may claim the subject vehicle upon presentation of proper documents. Further, if the claiming of the subject vehicle will be through a representative, he or she must present a duly executed Special Power of Attorney signed by the registered owner.

4. The undersigned respectfully manifests that this Manifestation be made part of the records of the instant case.



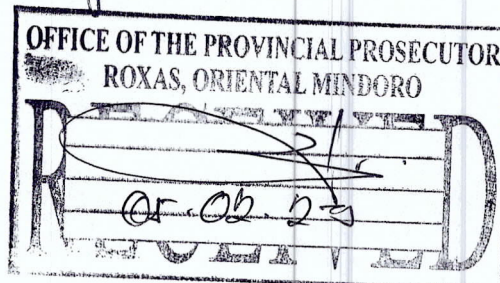
