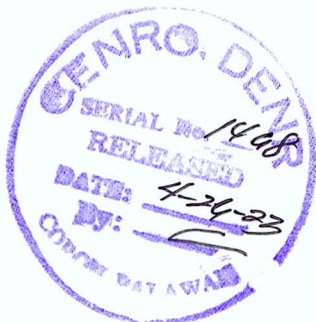

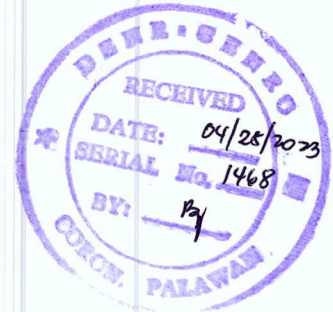

In compliance with marginal instruction of the OIC-CENR Officer re: abovementioned subject matter, please be informed that the undersigned Forest Product Monitoring station A&B (Busuanga) forest officers conducted hauling activities of said undocumented forest product and hereunder are the detailed events transpired on the premises of Alam- Indah Mini Resort at So.Kanlalanoi, Barangay Bogtong, Busuanga, Palawan.

1. That on the day time of February 01, 2023, the Forest Product Monitoring (FPMS) A & B Busuanga members together with OIC CENR Officer attend the ECAN board meeting held at the Conference hall of Municipal Government of Salvacion including with Sangguniang Bayan members, PCSD Representative and NCIP staff and other concern bodies.
2. That the same, during the discussion/ dialogue, SB Maria Ann D. Mercado and Municipal Administrator Dabuit proposed to the bodies to have an ocular inspection in the premises of Alam – Indah Mini Resort to check and inspect activities and construction transpired on the area.
3. Upon arrival on the premises of the Mini resort it as observed that some old buildings and function hall were being refurbished and restored and new swimming pool were constructed thereat,
4. That the same, during the ocular inspection, forest officers noticed the newly construct Foot bridge on the shore and being curious about what it was, we decided to approach and look on it and we found out that the floor surface of the foot bridge were compose of good lumbers. (Pls. See Attached Geotag pictures).
5. Upon we recognized the product, we call the attention of the foreman and ask question the permit for the said lumbers and the name of the owner of the same.
6. During the inspection and interview with the foreman, CENR Officer already arrive on the site and spoke to the foreman and said that the Alah-Mindah mini resort were bought to the Westtown Resort Coron and no permit presented by the foreman and he disclosed to us that he did not known the origin of source of the said lumbers.
7. Then, the OIC CENR officer directly instructed us to conduct inventory and scaling of the lumbers and get documented for possible filling of proper case on the alleged offender for possessing of Forest product without necessary permit coming from the concerned government office.
8. After documentation and Geotagging procedure and issuance of Apprehension Receipt, the lumber were already started to hauled and temporarily deposited at the premises of Municipal Government of Salvacion Busuanga, Palawan under the temporary custody of Environmental Management Specialist Mr. John Patrick Gajardo. 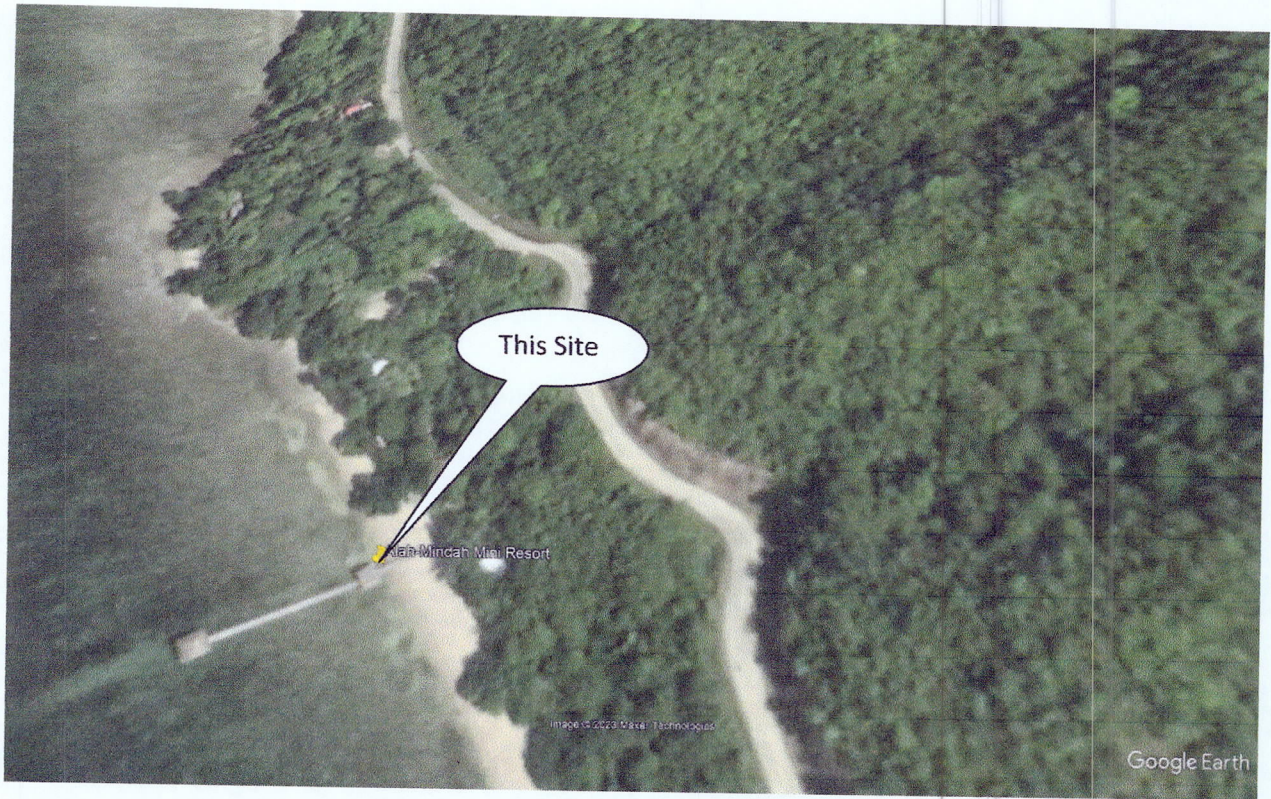
