ORIENTAL MINDORO

Attached is the transcript of the Minutes of the Administrative Hearing undertaken on the case entitled *Department of Environment and Natural Resources –versus– Joey Antonio Garga* for violation of R.A. 9175, as amended. Please be informed that Administrative Hearing was conducted last May 16, 2023, in accordance with Item 2, Section 7 of DAO 97-32 which was attended by the respondent, with the following observations:

- 1. Based on the spot report of the Municipal Police of Mansalay, their intel operatives led by PSSg. Joseph Froilan M. Manalo chanced upon a person in the act of cutting a gmelina tree using a chainsaw while they are conducting intel monitoring at So. Barubo, Brgy. B del Mundo, Mansalay, Oriental Mindoro.
- 2. MPS Mansalay immediately caught the said person identified as Joey Antonio Garga, 35 years old, single, chainsaw operator, and resident of So. Bailan, Brgy. Mabuhay, Roxas, Oriental Mindoro.
- 3. MPS Mansalay asked Joey Antonio Garga if he has a registration for the use of the chainsaw. He showed a permit but it was already expired for eight days. Upon verification from this office, the said chainsaw was owned by Jenna Daguno.
- 4. An administrative hearing was conducted on May 16, 2023, after the turn-over of the documents from the Municipal Police of Mansalay.
- 5. During the administrative hearing, Joey Antonio Garga admitted that he cut one gmelina tree using the said chainsaw with an expired permit from this office. He only did it because his *kumpare* "Dudoy" asked for his help so the latter can use it for his house. He said that he borrowed the said chainsaw from the owner Jenna Daguno's husband at the latter's store.

- 6. He further claimed that they asked for the permission of the barangay and the police before cutting the said one Gmelina tree which the police allowed them. However, to their surprise, they were apprehended by 2 policemen in civilian attire after they cut down the tree.
- 7. Also, during the administrative hearing, the owner of the said chainsaw, Jenna Mayor Daguno, claimed that she did not know that her chainsaw was borrowed from his husband at their store. With that then, she denied any participation in the said cutting of the tree as she was at her house at that time of apprehension. She claimed that she was not able to apply for the renewal of the expired permit of the chainsaw because her mother and another relative died at Odiongan, Romblon. She prayed that her chainsaw be brought back to her.
- 8. The subject chainsaw was turned over by the apprehending officers to the nearest authorized Seizure Officer pursuant to Section 3 of DAO 97-32.

FINDINGS AND RECOMMENDATIONS:

The undersigned after having reviewed the documents at hand, the statements of the respondent, and the Administrative Hearing conducted, determines that the STHIL Chainsaw bearing Serial No. S-181964948 with an expired permit was used in the act of cutting the gmelina tree. However, the said one felled gmelina tree was only to be used in the premises of the house of the owner and the certificate of registration of the said chainsaw was only expired for eight (8) days at the time of apprehension. The chainsaw's owner was not able to promptly apply for renewal because her mother and another relative died at Odiongan, Romblon. Such facts show that the respondent has no ill will to transgress the law. This act is not in violation of Republic Act No. 9175 as a humanitarian consideration but with a stern warning to the respondent.

In view of the foregoing, these are the findings and recommendations of the hearing officer:

JOEY ANTONIO GARGA, the respondent for CENRO Case No. 2023-02, did not violate R.A. 9175. The STIHIL CHAINSAW bearing Serial No. S-181964948 shall **be released** to the owner.

This case has been filed at the Regional Trial Court Br. 43, Roxas, Oriental Mindoro, with Criminal Case No. M-23-3593 for violation of R.A. 9175.






