This pertains to the email from the PFMS-CDD MIMAROPA and from your Office dated April 5 and 19, 2023 respectively on the above subject.

Please be informed that there are four (4) CBFM areas under this jurisdiction wherein the three (3) of these will be converted to PACBRMA after its expiration because they are within the Malampaya Sound Protected Landscape and Seascape (MSPLS), while the other one which is the San Fernando Agroforestry Producers Cooperative (SFAFPC) will remain as CBFM. This Office has coordinated the SFAFPC regarding the said expansion, however, they committed to grie feedback after their meeting on April 29, 2023
