Respectfully forwarded is the memorandum of CENRO Brooke's Point, Palawan dated April 19, 2023 relative to the above subject.

Per memorandum, the apprehended undocumented lumber of different species were declared abandoned due to no claimant/owner appeared or claimed the said lumber in the office of CENRO Brooke's Point, Palawan.

The said apprehended undocumented lumber has an estimated fair market value of Php9,277.75. The apprehended item was brought to the compound of DENR CENRO Brooke's Point Balabac Sub-Station Office for safekeeping purposes.

The Notice to the Public dated March 17, 2023 was posted in different conspicuous places in relation to section 8 of DAO 1997-32. However, no claimant has appeared on the said office. Therefore, the absence of the owner/claimant to appear shall be deemed a waiver of their rights to the item apprehended in favor of the government.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended lumber.

Submitted herewith is the summary of the Administrative Confiscation Proceedings together with the pertinent documents anent the above-cited subject treated under DAO 97-32.

T. **FACTS OF THE CASE**

The apprehension was made by the CENRO Brooke's Point Balabac Sub-Office personnel on March 17, 2023 at around 11:00 in the morning in response to the information received from the report of the Barangay Officials concerning the alleged piled lumbers that resulted to the apprehension of Fifty-one (51) pieces of assorted lumbers species with a total volume of 545.74 board feet. The subject forest products were discovered and found no claimant or abandoned during the apprehension and same were hauled and deposited at CENRO Brooke's Point Balabac Sub-Office compound for safekeeping.

II. NOTICE OF HEARING

Pursuant to the provisions of Department Administrative Order No. 97-32 Re: Rules for Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 08, Item No. 03, posting of notice to the public for the conduct of administrative hearing for three (3) consecutive weeks was conducted by this Office at the different conspicuous place of Balabac, Palawan.

III. **EVALUATION**

In spite of the notices posted, however, no claimant has appeared in this Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their right to the items apprehended in favor of the government.

IV. RECOMMENDATION

In view hereof, it is recommended that the fifty-one (51) pieces of assorted lumbers species with a total volume of 545.74 board feet apprehended at Sitio Timbangan, Barangay Indalawan, Balabac, Palawan be forfeited in favor of the government.
