56 BOARD FEET IN BRGY. ISUGOD, QUEZON, PALAWAN

WITHOUT LEGAL DOCUMENTS

Respectfully forwarded is the memorandum of CENRO Quezon, Palawan dated May 12, 2023 relative the above subject.

Per memorandum, the apprehension was made on March 17, 2023 at around 8:20 A.M. by the personnel of PNP-2nd SOU-MG during the patrolling with their vehicle within the vicinity of Barangay Isugod, Quezon, Palawan and heard a sound of chainsaw operation near the highway. Immediately, they stopped and proceeded to the area and approached the two (2) individual persons who caught on the actual operation. Due to failure to present a cutting permit, the operation is considered a violation to Section 77 of PD 705. However, the chainsaw used during that time have a registration from the PCSD but upon verification of the permit by the PNP-MG, they noticed that the limitation of use of the said chainsaw is outside of its jurisdiction and intended for planted trees within a private property covered with Original Certificate Title No. E-14390. The arrested person were brought to the PNP-2nd SOU-MG Station for further investigation and documentation. The apprehended lumber were deposited in their Office compound at Sitio Bliss, Barangay Alfonso XIII, Quezon, Palawan for safe keeping purposes. The estimated fair market value of lumber is Php2,240.00, while the one (1) unit chainsaw was turned over to PCSD for proper disposition.

Notices of hearing were sent to both parties and the hearing was conducted on March 18, 2023 in relation to Section 7 of DAO 1997-32.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended lumber/forest product.

FEET IN BRGY ISUGOD, QUEZON, PALAWAN

Submitted herewith the minutes of the Administrative Confiscation Proceedings together with pertinent documents anent the above-cited subject treated under DAO 97-32. The hearing was conducted on April 17, 2023 at DENR-CENRO Quezon, Palawan.

Please be informed that prior to the conduct of hearing, a notice of hearing was given to the respondents informing them of their privilege to exercise their right to hire a legal counsel of their own choice pursuant to the provisions of the New Constitution. However, despite the considerable period of time since the notice of hearing was served, this office did not received any notice or motion from the respondents to re-schedule the hearing for reason that they did not get their own lawyer.

Further informed that during the scheduled date of hearing, the respondent asserted to proceed the hearing even without the assistance of their own legal counsel.

### I. FACTS OF THE CASE:

WHAT:

Apprehension and seizure of four (4) pieces of undocumented Kaatoan

lumbers having a total volume of 56 board feet.

WHEN:

On or about 8:20 AM of March 17, 2023

WHERE:

Brgy. Isugod, Quezon, Palawan

WHO:

Mr. Jaron Valdez Villo and Mr. Erwin S. Atonducan, both are residents of

Brgy Isugod, Quezon, Palawan.

HOW:

On or about 8:00 AM of March 17, 2023, the PNP-MG while conducting patrolling with their service vehicle in the vicinity of Barangay Isugod, Quezon have heard a chainsaw operation along the national highway. Upon

verification, two (2) individuals were caught in the actual illegal logging operation. Due to lack of permit presented by the respondent, the apprehending team declared apprehension. The apprehended items were deposited at PNP-MG office located at Sitio Bliss, Bgy Alfonso, XIII, Quezon, Palawan.

# II. PRESENTATION OF PARTIES CONCERNED (Apprehending Officers and Respondents):

1. During the hearing, the apprehending officers were not present but they were able to submit their "Malayang Sinumpaang Salaysay". Based on the malayang sinumpaang salaysay of PCpl Edmark G. Guyo, on or abour 8:20 AM of March 17, 2023, the PNP-2<sup>nd</sup> SOU-MG while conducting mobile patrolling with their service vehicle within the vicinity of Barangay Isugod, Quezon, Palawan have heard a sound of chainsaw operation near the highway. Immediately, they stopped and conducted surveillance and cautiously move toward the area where the sound of chainsaw come from and spotted two (2) individuals one of them is operating a chainsaw. They immediately approach the two persons and ordered them to switch off the chainsaw engine and subsequently identified their team as members of PNP-MG.

In the course of field verification/investigation, the respondents failed to present a cutting permit from the DENR, however, they presented a certificate of registration from PCSD for the chainsaw. Upon verification of the certificate of registration, the PNP-MG noticed that the use of chainsaw is limited only for planted trees within a private property covered with Original Certificate Title No. E-14390. Considering that the respondents have no permit to cut and for reason that the tree being cut down is not a planted tree but rather a naturally grown tree, the team of PNP-MG declared arrest and apprehension and they informed the respondent of their violation of Section 77 of PD 705 and RA 9175 and subsequently informed their rights under the Miranda Doctrine.

The arrested persons were brought to the PNP-2<sup>nd</sup> SOU-MG station for further investigation and documentation and the apprehended lumbers and one unit of chainsaw were deposited in their office compound at Sitio Bliss, Alfonso, XIII, Quezon, Palawan.

- 2. In the same hearing, Mr. Jaron Valdez Villo explained that he is not actually a helper of chainsaw, but being a student and in order to earn some money for his study, he always take all possible job opportunities that he can do. On the other hand, Mr. Erwin S. Atonducan acknowledged that he is the operator of chainsaw owned by Mr. and Mrs. Corazon Cabili.
- 3. In that hearing, Mr. Antonio Peres Cabili husband of Corazon Cabili explained that he just instructed the two (2) boys (mga apo) to cut the Bangkal tree to give enough space and sunlight exposure to other crops. Further, he narrated that the area where cutting happened is still within their private property.

### III. APPLICABLE LAWS AND POLICIES:

- 1. Section 77 of PD 705 as amended or Revised Forestry Code of the Philippines "Cutting, Gathering and/or collecting Timber or other Forest Products Without License- any person who shall cut, gather, collect, remove timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code; Provided, that in the case of partnerships, associations, or corporations, the officers who ordered the cutting, gathering, collection or possession shall be liable, and if such officers are aliens, they shall, in addition to the penalty, be deported without further proceedings on the part of the Commission on Immigration and Deportation.
- 2. Department Administrative Order No. 97-32 dated 1997 Rules for the Administrative Adjudication of Illegal Forest Products and the Machinery, Equipment, Tools and Conveyances used in the commission of crimes.

## IV. FINDINGS/EVALUATION

- 1. Though the chainsaw used in cutting of one (1) piece of Kaatoan Bangkal has a valid Certificate of Registration, however, the cutting has no permit from the DENR which is a violation of Section 77 of PD 705 as further amended;
- 2. In view of the above findings and facts presented, it was found that there were sufficient and convincing evidences to support the finding of probable cause to charge **Mr. Jaron Valdez Villo and Mr. Erwin S. Atonducan** for violation of Section 77 of PD 705 as further amended by E.O. 277 and R.A. 7161.
- 3. Be informed that only the apprehended lumbers were subjected for the Administrative Adjudication Proceedings, the Chainsaw was turned over by the PNP-MG to PCSD.

### V. RECOMMMENDATION

1. In view of the above findings and evaluation, it is recommended that the four (4) pieces of undocumented Kaatoan lumbers having a total volume of 56 board feet be confiscated in favor of the government in addition to the filling of case against the above –mentioned offender for violation of Section 77 of PD 705 as further amended by E.O. 277.






