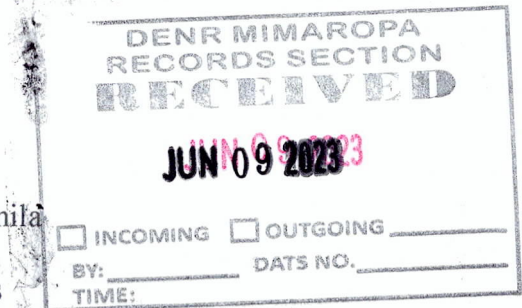

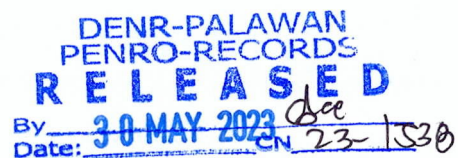

(SFAFPC) AS PART OF THE RE ENTRY ACTION PLAN
(REAP) DURING ENRA SPECIALIZED COURSE ON
COMMUNITY ORGANIZING TRAINING**

Respectfully submitting is the report of the undersigned on the above subject.

Please be informed that the above mentioned reorganization was conducted on April 28-29, 2023 held in MH Canteen, Barangay San Fernando, El Nido, Palawan. The said activity is part of the Re Entry Action Plan (REAP) of the undersigned during ENRA Specialized Course on Community Organizing Training. It aims to refresh the PO on the pertinent laws, rules and regulations that govern the CBFM implementation, elect and install the new set of officers of SFAFPC, know the status/current situation of SFAFPC and to organize the activities of the PO for 2023.

During the two (2) day activities, the following were conducted, to wit:

- a. Preliminaries
 - The activity was commenced with the prayer followed by the National Anthem. Afterwards, a welcome message from Mrs. Adelina U. Sado was heard as well as the messages delivered by Punong Barangay Isidro Bacaltos and CENRO Conrado M. Corpuz.
- b. Series of presentation/re-orientation on salient features of laws that govern the CBFM implementation such as CDA Rules and Regulations and the significance of Cooperative, PD 705-Forestry Law, Guidelines on Utilization of Resources within the CBFM area, EO No. 263-CBFM, RA 9003 – Ecological Solid Waste and RA 8371-IPRA Law.
 - The questions and answer were catered after every presentations.



- c. Election and Induction of newly elected Officers.
 - The SFAFPC members decided to replace all the positions from BOD down to the committees and inducted after the elected Officers by the assistance of CDA and CENRO-CBFM Unit
- d. Visioning exercise
 - The community visioning has been discussed, however, there was no visioning exercise made due to time constraint, instead, the PO decided to review their vision, mission, goals and objectives of their submitted Community Resource Management Framework (CRMF).
- e. Appreciative Inquiry
 - Instead of identifying the strengths and best practices, due to time constraint, the PO decided to review the strengths and opportunities as well as the strategies and activities identified in their submitted CRMF
- f. CO Initiative Assessment
 - The assessment results showed that of the four (4) components, the Organizational Development obtained a highest score of 3.13 while the lowest score of 1.0 is the Advocacy, it is because there was no integration of the PO's strategies and activities in the municipal or Barangay Annual Investment Plan. Hence, Punong Barangay Bacaltos being a member of the SFAFPC, committed to integrate some plans of the PO identified in their CRMF
- g. Planning of the activities for 2023
 - There were fifteen (15) activities that has been discussed by PO members during the planning based on their CRMF and Five Year Work Plan to be implemented this CY 2023, wherein they prioritized the establishment and operation of wood, bamboo and handicraft project including the purchase of other equipment and Operation of NTFP business. The PO reminded that they can operate wood from planted trees and NTFP business when the CRMF is approved. Meanwhile, the CBFM Unit of this Office is still waiting for the instruction of the higher Office on the CRMF of the SFAFPC since it was submitted in 2019.

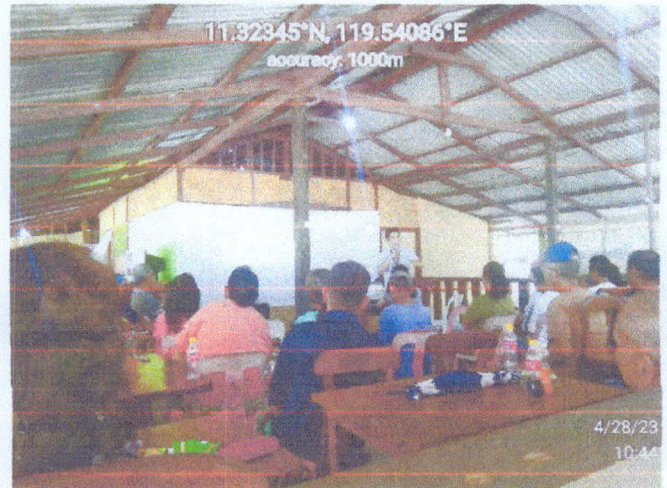


