Please be informed that on February 9, 2023, this office conducted habitat surveillance of threats and damages at Bgy. Manlag, El Nido, Palawan. Based on the report, the team observed cuttings of mangrove trees in five (5) different locations inside the mangrove area, two (2) fishponds, and nine (9) abandoned crab traps which falls within Strict Protection Zone (SPZ) based on Protected Area Zoning.

The team recommends to call out the attention of Barangay Local Government Unit (BLGU) of Bgy. Manlag, El Nido, Palawan, conduct in depth investigation to determine the owners of the said fishponds, and intervention of Protected Area Management Board (PAMB). Thus a letter dated April 25, 2023 was sent to Punong Barangay Janet Tamayosa of Bgy. Manlag, El Nido, Palawan for their information and appropriate action.




