Forwarded herewith is the report of APASu Jerry P. Bautista dated April 18, 2023, relative to the above subject hereof in compliance with the memorandum dated February 06, 2023, by ARD Maximo C. Landrito, and received by this office on April 11, 2023.

Please be informed that a report of APASu Bautista revealed that the reported illegal cutting of one Magtalisai gubat was found 163 meters away from the warden's camp. However, during the conduct of investigations and interrogations with the assigned Wardens, no persons had been noticed in the area. As they continued patrolling again they found another one-cut Magtalisai tree of the same size and specie as the previous one with an approximate distance of 1 km from the wardens' camp based on their observation the alleged person who cut the trees was only one and it will be used for the same purpose.

Relative hereto, and considering that no perpetrators were found in the incidents, monitoring, and surveillance within the area of RIWS were persistently conducted by PAMO field personnel and close coordination with different government law enforcement agencies as well as fisher folks and barangay LGUs to ascertain the culprit and in order to prevent this incident from happening again.

This is in compliance to the Memorandum of The OIC, Assistant Regional Director for Technical Services dated February 6, 2023 which was received by this office on April 11, 2023 and pertains to the investigation conducted in the alleged cutting of one Magtalisai tree with 22 cm. in diameter and 26 meters in length within the protected area of RIWS which we found the cutting of said tree 163 meters away from the warden's camp. We conducted interrogation to the wardens assigned therein but accordingly they were not able to see nor observe person who cut the tree. Continuous surveillance and foot patrolling around the area were conducted and we found another one cut and felled tree of same species, size and length with the first tree approximately one kilometer away from the warden's camp. We noticed that person who cut the first tree is the same with the second tree and might be used for one same purpose.

Considering that no one can point out the perpetuators we coordinated with the other law enforcement agencies the PNP Maritime, PCG, and the Barangay officials of Bgy. Antipuluan, Panacan II, Panacan and fisher folks of same Barangays. The PAMO also conducted patrolling and surveillance even night time in order to have our continuous visibility to prevent this threats of destruction.


