Respectfully submitted is the Memorandum dated April 26, 2023 of the OIC, PENR Officer of Occidental Mindoro regarding the abovementioned subject. This is part of accomplishment in compliance to OO1 – Natural Resources Conservation and Development Program, V. Management of Caves and Cave Resources Outside PAs, Sub-Program – I. Cave Assessment and Classification with performance indicator "No. of caves assessed and classified" in the province of Occidental Mindoro.

Onoda Caves (1, 2, and 4) lies within the Forestland per LC Map No. 631 dated January 21, 1927. It is under the administrative jurisdiction of Barangay Vigo, Lubang, Occidental Mindoro.

Onoda Cave 1 has a total land area of 54.27 square meters, 13.92 meters of total length (leg 1), and 14.92 meters of total length (leg 2). It has 6.366-meter ceiling height and 5.67-meter mouth opening width. Onoda Cave 2 has a total land area of 26.46 sq.m., a total length of 13.68 meters, a mouth opening width of 3.50 m, and a ceiling height of 3.091 m. Onoda Cave 4 has a total land area of 57.59 sq.m., a total length of 24.21 meters, a mouth opening width of 6.85 meters and ceiling height of 1.113 meters.

The geological formation inside the cave are draperies, flowstone sheets, moonmilk, and soda straws. The majority of the cave's wildlife was comprised of cave gecko, fruit bat, and swiftlets. Threats included those brought on by human activities such as vandalism, solid waste, and unrestricted tourist or recreational activities.

Based on the assessment results and the initial classification, the Team recommends classifying Onoda Cave as Class II, or caves with areas or portions which have



Maujo, Bulalacao released two (2) wildlife species into the wild on March 03, 2023 as part of the celebration of World Wildlife Day. The species were (2) Philippine Long – tailed Macaque (Macaca fascicularis philippensis) and (1) White Bellied Sea Eagle (Haliaeetus leucogaster). Please be informed that the MEA was conducted during the 1st Quarter CWFR PAMB Meeting on February 10, 2023 at Barangay Linawan, San Andres, Romblon. A total of eleven (11) respondents from the CWFR PAMB such as the Protected Area Superintendent (PASu), Municipal Officials and Punong Barangay/members of the Barangay Council from the Municipalities of Calatrava, San Agustin and San Andres, Romblon participated in the assessment and evaluation of management of CWFR.

The following are the summary results of the MEA guided by the BMB Technical Bulletin No. 2018-05 "Adopting the Management Effectivess Tracking Tool (METT) for Assessing and Monitoring Management Effectivess of Protected Areas":

1. On threats:

- . a. Overall, the respondents perceived that all threats presented are considered low levels of threat. Among the twelve (12) threats identified, the biological resource use and harm within a protected area had the highest mean value of 0.85 while the energy production and mining within or outside a protected areas had the lowest mean value of 0.07. On the average, total mean score is 0.36. The same level of threat was recorded in the previous MEA in CY 2020, however, the most perceived threats were the geological events, climate change and severe weather and biological resource use and harm.



The Minutes was presented and approved by the Management Board during its En Banc meeting on February 2, 2023.

The En Banc meeting was presided by Mr. Kenn B. Palay, the representative of Congressman Edgardo Villagracia Lim Salvame, 1st District of Palawan and attended by twenty-eight (28) out of forty (40) regular members of the PAMB. It was noted that as of this En Banc meeting, the MSPLS PAMB has no official representative from the private sector, on which we have already called the attention of the PAMO MSPLS in our previous PAMB-related memorandum.

In recognition of the importance of mangroves, seagrass and coral reefs, the PAMB approved Resolution No. 8, Series of 2022 "Enjoining the Active Participation of Concerned Barangay Local Government Units (BLGUs) in the Monitoring of Corals, Seagrass, and Mangroves within Malampaya Sound Protected Landscape Seascape (MSPLS)."

The MSPLS PASu explained the importance of this resolution relative to the conservation and protection of mangroves, seagrass and coral reefs thus, the need for






Please be informed that the thirty-five (35) flora species and thirty three (33) fauna species featured in the photo checklist were based on the result of terrestrial and coastal and marine ecosystems survey conducted in 2006, included therein are the threatened species endemic in Palawan. Other data on the checklist were likewise based on the result of recent assessment conducted in the PA through the Biodiversity Assessment and Monitoring System (BAMS).

We have initially reviewed the booklet with our comments for PAMO ENTMRPA to consider in the revision/finalization. Respectfully submitted is the attached copy of the Completed Staff Work (CSW) regarding the above-cited subject.

Records show that on May 26, 2010, FLAgT No. 09-2010 was issued by then Secretary Horacio C. Ramos to Diwaran Resorts Philippines, Inc. (DRPI) represented by Alexander R. Reyes, over 55.05 hectares of unclassified public forest in Diwaran Island, Brgy. Marcilla, Coron, Palawan.

Pursuant to Section 14 of DAO No. 2004-28, as amended by DAO No. 2009-16, it is stated that:

"Section 14.2 The holder shall submit within six (6) months from the issuance of the FLAgT a Comprehensive Development and Management Plan (CDMP) for the FLAgT Area. The CDMP shall provide, among others, for appropriate schemes, arrangements, or activities that will maximize the use of the FLAgT Area, which are compatible with the Tourism Project and shall benefit the host community. The CDMP shall be submitted to, and approved by, the Regional Executive Director concerned, after review and deliberation by a Review Committee composed mainly of technical staff of Forest Management Sector. The approved CDMP shall form part of the FLAgT.

Thus, the Site Management Plan referred to under Section 15 of the said DAO shall be replaced with "Comprehensive Development and Management Plan " (CDMP.)"

Further, Section 17.2 of DAO No. 2004-28 provides that the following are the grounds for suspension and cancellation of FLAgT:

17.1 For Suspension:

17.1.1 Failure of the FLAgT holder to settle administrative dues

including government share after three (3) consecutive notices, after they become due and demandable.

17.1.2. Failure of the FLAgT holder to provide the necessary protection of the area.
