ANSWER

COMES NOW, THE LOCAL GOVERNMENT UNIT OF CORON, PALAWAN, a nominal defendant and herein represented by the Municipal Mayor, unto this Honorable Court, most respectfully avers that:

- 1. Defendant is aware that there was a Contractual Joint Venture Agreement (CJVA) executed by and between the Provincial Government of Palawan and BCT Trading & Construction and 428 Hi-Tech Group, Inc.;
- 2. Apparently, the Local Government Unit (LGU) of Coron, Palawan is not a signatory, hence, not a privy to the said CJVA. Copy of the CJVA is hereto appended as **Annex "A"**;
- 3. Thus, All the allegations in the Complaint are denied for lack of knowledge or information sufficient to form a belief as to the veracity or falsity thereof, the allegations therein being matters only known to the parties of the said CJVA;
- 4. The basic principle of relativity of contracts is that ¹contracts can only bind the parties who entered into it and cannot favor or prejudice a third person, even if he is aware of such contract and has acted with knowledge thereof;
- 5. Further, relative to the doctrine of privity of contract, it provides that "where there is no privity of contract, there is likewise no obligation or liability to speak about";
- 6. It bears stressing also that there is nothing in the provisions of the CJVA which state that the LGU of Coron, Palawan will

assume any obligation or liability in case of breach of any of the parties of the provision/s in the CVJA.
