



Summary Patrol Report Region 04B - Romblon



Patrol distance covered by each forest ranger





Respectfully submitting the summary report of patrolling using LAWIN Biodiversity and Forestry Protection System conducted in Sibuyan Island, Romblon from April 21-May 20, 2023 to wit;

Records and observations collected by the data manager of SMART LAWIN from the three (3) patrol teams shows that a total of **14.47** kilometers were patrolled from April 21-May 20, 2023.

Patrollers of Sibuyan island conducted monitoring and patrolling in So. Bangko-bangko, Brgy. Mabini, San Fernando, Romblon and recorded two(2) newly illegal small scale gold mining holes in the So. Bangko-bangko site, patrollers already coordinated the LGU's about these threats and will continue to take action after a week. There are also discovered illegal cutting of trees in So. Malamig, Brgy. Tampayan, Magdiwang, Romblon and was recorded by Park Ranger Emeterio Quarre while he is on patrolling.


The Data Manager generated a single patrol report for every team who conducted the patrolling for easy and accurate monitoring of their action taken on the recorded threats. A total of **151.02** kilometers were recorded by the data manager from January 2023 to present.





The Chart below shows the threats recorded by the LAWIN patrollers for monthly monitoring.




The chart below shows the kilometers patrol recorded by LAWIN patrollers for monthly monitoring.







