Respectfully forwarded is the request of Mr. Eric L. Oria for renewal of Wildlife Farm No. MIMAROPA-2019-0001 and Collector's Permit No. MIMAROPA-2019-0001 issued on August 29, 2019 valid until August 31, 2023. Pursuant to the Provisions of Republic Act No. 9147 series of 2001, its implementing Rules and Regulations (Joint DENR-DA-PCSD Administrative Order No. 01-2004), and DENR Administrative Order No. 2004-55, the INSECT HAVEN BUTTERFLY AND INSECT CULTURE is required for renewal of Wildlife Farm Permit and Wildlife Collector's Permit (WFP/WCP) at Barangay Cawit, Boac, Marinduque.

Based on the inspection/verification conducted by personnel of this Office, the said butterfly farm has a total area of 300 square meter situated within a private land identified as Lot. 22374, Cad. 544-D, C-02 covered with Transfer Certificate of Title No. 061-2013000071 located at Brgy. Cawit, Boac, Marinduque. During the inspection/verification of the area, the farm has available host plants such as; Citrus species, Parsonsia species, Aristolochia tagala, Adenia palmate, Adenia species, Sili-sili, Asahar, Eudio species, Raphistemma species, Bago puso, Tylophora species, Guyano, Guava, Strawberry, Ipomeoa bata, Gymanthera species.

Furthermore, the main source of income of his family is breeding and trading of butterflies. Most of the family members have knowledge/expertise on butterfly breeding.

Based on the findings of the personnel of this Office, the said butterfly farm's area is approximately 300 square meters with flat topography. It is classified as agricultural land and planted with bananas as well as wide variety of local butterfly food plants. In addition, based on the findings the cleanliness of flight cages purposely for mating and egg laying activities were maintained to prevent possible contamination and/or spread of pest/diseases which may affect the survival of both the captive and the wild population of butterflies in the area.

Considering that the applicant is technically trained and capable to pursue suitable development and conservation of butterfly, it is therefore recommended that the renewal of Wildlife farm and Collector's Permit (WFP/WCP) be granted in favor of Mr. Eric L. Oria subject to existing forestry, law, rules and regulations.

I. BACKGROUND:

In Pursuant to the Provisions of Republic Act No. 9147 series of 2001, its implementing Rules and Regulations (Joint DENR-DA-PCSD Administrative Order No. 01-2004), and DENR Administrative Order No. 2004-55, the **INSECT HAVEN BUTTERFLY AND INSECT CULTURE** represented by Mr. Eric L. Oria with an address at Barangay Cawit, Boac, Marinduque applied for renewal for Wildlife Farm No. MIMAROPA-2019-0001 and Collector's Permit No. MIMAROPA-2019-0001. Please be informed that the personnel of this Office conducted ocular inspection of the above-mentioned butterfly farm. Hereunder are our initial findings, to wit:

- ❖ The INSECT HAVEN BUTTERFLY AND INSECT CULTURE is a business entity which aims to enhance conservation of local butterfly species through collection and captive breeding which contribute in the improvement of breeding techniques.
- The above-mentioned butterfly farm has a total area of 300 square meters situated within a private land identified as Lot. 22374, Cad. 544-D, C-02 covered with Transfer Certificate of Title No. 061-2013000071 located at Brgy. Cawit, Boac, Marinduque.
- During the inspection/verification of the area, they have available host plants such as; Citrus species, Parsonsia species, Aristolochia tagala, Adenia palmate, Adenia species, Sili-sili, Asahar, Eudio species, Raphistemma species, Bago puso, Tylophora species, Guyano, Guava, Strawberry, Ipomeoa bata, Gymanthera species.

- According to the applicant, the main source of income of their family are breeding and trading of butterflies. Most of their family have knowledge/expertise on butterfly breeding. The proof of scientific expertise of the applicant are as follows;
 - Properly know the different species of butterfly in the Province of Marinduque.
 - Proper knowledge and actual involvement in breeding and cultured of butterflies
 - knowledge on the different host plants of butterflies
 - Proper knowledge on metamorphosis cycle of the butterfly
 - Proper knowledge the methods for butterfly collection
 - knowledge on the factors affecting the production of pupae.

- Payment of fees;
- Surrender the original copy of WCP and WFP.

III. COMMENTS AND OBSERVATIONS:

- Their butterfly farm's land area is approximately 300 square meters with a flat topography, it is classified as agricultural land and planted with few bananas as well as a wide variety of local butterfly food plants.
- * Flight cages purposely for mating and egg laying activities are clean properly maintained.
- Properly observed cleanliness and sanitation in the maintenance of farm facility to prevent possible contamination and/or spread of pest/diseases which may affect the survival of both the captive and the wild population of butterflies in the area.
- Ten percent (10%) of the total production of bred butterflies on was released for replenishment of the wild population.

IV. RECOMMENDATION:

Considering that the applicant is technically trained and capable to pursue suitable development and conservation of butterfly, it is therefore recommended that the renewal of Wildlife farm and Collector's Permit (WFP/WCP) be granted in favor of Mr. Eric L. Oria subject to existing forestry, law, rules and regulations.
