**I. REFERENCE**

In compliance with the target activities of Technical Services Division - Monitoring and Enforcement Section, please be informed that the Wildlife Traffic Monitoring Unit of PENRO Marinduque conducted monitoring at seaports and airport in the province of Marinduque for the month of May 2023.

**II. FACTS/FINDINGS**

Please be informed that the team coordinated with the concerned personnel of different agencies/offices regarding the conduct of monitoring within areas for possible illegal transport of wildlife and even forest products.

Be informed that the team proceeded at the various seaports namely Port of Gasan at Barangay Dos, Gasan, Port of Balanacan, Balanacan, Mogpog and Port of Cawit, Barangay Cawit, Boac, all in the province of Marinduque. At the Port of Cawit, there still no schedule of trips of passenger vessels in the port. Only cargo vessel and barge were berthed in this port to unload cements and local rice (NFA).

In addition, at the Marinduque Airport located in Barangay Masiga, Gasan, there is still no domestic flight in said airport. During the time of wildlife traffic monitoring, no illegal transport of wildlife encountered by the monitoring team.

**III. RECOMMENDATION**

The team recommends the continuous monitoring within the seaports and airport to prevent any illegal activity and to install a Monitoring Station within the port particularly at the Port of Balanacan, Mogpog and Port of Gasan, Barangay Dos. Attached herewith area geo-tagged photos of the said activity.
