- The Original and two copies of the Geodetic Engineer's Certificate or, in lieu thereof, a Certification from the Regional Technical Director as to its availability;
- A certification in triplicate of the Provincial City or Municipal Assessor of the assessed value of the land at its last assessment for taxation or, in the absence thereof, that of the next preceding year, in case the land has not been assessed an affidavit in triplicate (Judicial Form 81) of the market value of the land signed by three disinterested witnesses;
- All original muniments of title of the applicant which prove ownership of the land.


In consonance to these, may I respectfully request in writing for an update of my request and other requisites needed to expedite the facility of my request. Mabuhay!

6. All original muniments of title of the applicant which prove ownership of the land.


Please be informed that your request cannot be granted for the reason that our Office was razed by fire last May 28, 2018 and we cannot confirm the existence of the folder/s if there are any, containing the records of your request.

However, based on our database of decentralized survey records saved from the fire, Plan II-7480 covering the parcel of land situated in Coron, Palawan was among those survey records that was already turn-over/decentralized to the DENR-Region IV-B (MIMAROPA) dated October 28, 1994 which was included in bundle number 8.
