Municipal Resolution No. 69, series of 2023

A RESOLUTION RESPECTFULLY REQUESTING THE OIC REGIONAL EXECUTIVE DIRECTOR LORMELYN E. CLAUDIO, CESO IV, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) FOR THE LAND RECLASSIFICATION OF THE MUNICIPALITY OF AGUTAYA FROM TIMBERLAND TO ALIENABLE AND DISPOSABLE (AD) LAND

Introduced by Hon. Henry G. Aban

WHEREAS, the Municipality of Agutaya for so many decades remained classified as timberland which now need re-classification as this is necessary for its development;

WHEREAS, this is also one of the problems of the LGU when the National Government agencies have some projects for Agutaya that requires lot as counterpart for the project to be constructed of which it must be titled one;

WHEREAS, one of the projects given by the National Government, the National Housing Authority (NHA), is the housing project for Typhoon Yolanda victims in 2013 due to the LGU is classified as timberland and the supposed contractor requires titled land for the project, then the housing project amounting to P55M were then returned to the NHA;

WHEREAS, it is now time and hoping through the assistance of the concern government agency that the Municipality of Agutaya will be possibly reclassified from timberland to alienable and disposable (AD) land;

NOW, THEREFORE, on motion of Hon. Joey B. Zumaraga duly seconded by Hon. Arlito B. Bacosa, Jr. be it




