#### Annual Waterbirds Census CY 2023

The Annual Waterbirds Census was conducted on January 24-25, 2023 in partnership with City ENRO and CENRO Puerto Princesa City at Snake Island NCMCR. During the assessment, twenty-two (22) bird species were observed, with a total of one hundred fifty-one (151) individuals counted from January 24, 2023 at 9:00AM to 10:25PM and January 25, 2023 at 5:30AM to 8:00AM with a sunny weather.








Figure 1: Six main fishing activities identified in the island for the month of January to March 2023 with Drive-in net has the highest rate followed by Crab Gill Net, Hook and line, Gill net, gleaning and with the spearfishing has the lowest.




Figure 2: Nine (9) identified barangays that benefited on marine resources of Snake Island were recorded for the 1st quarter of CY 2023, namely: Barangay Tagburos with the highest number of fisherfolks recorded followed by Barangay Manalo, Maruyugon, Sta. Lourdes, Salvacion, San Jose, Sicsican, Tagbato and Pandan.




Figure 3: Total number of marine debris collected for the month of January to March 2023 with March as the month with the highest number of collection and January as the month with the lowest number of collection. The marine debris with the highest number of collection are plastics followed by Residual

#### **Monitoring of Gleaning Activities**

A total of fifty-five (55) individuals were recorded conducting gleaning activity (panginginas) at Snake Island for the 1<sup>st</sup> quarter, composed of thirty-two (32) males and twenty-three (23) females, from January to March 2023 with most coming from Barangay Manalo followed by Barangay Tagburos, Tagbato, Maruyugon, Sta. Lourdes and Barangay Salvacion.




Figure 4: Top four species of sea shells collected by gleaners from January to March 2023: Strombus urceus or locally known as "sikad- sikadd", Anadara antiquate or "bakalan", Lambis scorpius or "ranga - ranga" and Laevistrombus canarium or "pasyak".





For this quarter, a total of 830 liters of fuel were consumed for the official use of Snake Island NCMCR speedboat.




Figure 4: Graph showed that the month of January 2023 has the highest amount of gasoline consumed followed by March and February with the lowest rate gasoline consumption.




