We write in reference to the letter dated 08 March 2023 of Ms. Amelia D. Villaluz, addressed to President Ferdinand R. Marcos, Jr., requesting assistance in securing a Residential Patent Title over a real property located at Lot 68 Sitio Sia Purok Milenyo, Barangay Buenavista, Puerto Prinsesa City, Palawan, owned by spouses Felix Abrea and Natividad Abrea.

Records disclose that, the property allegedly owned by the spouses Abrea was transferred, without their knowledge and consent, from Barangay Buenavista to Barangay Macarascas. Per Ms. Villaluz, the anomalous transfer of the subject property was initiated by Barangay Captain Romea Labrador, allegedly along with various employees of City Environment and Natural Resources Office (CENRO), Provincial Environment Natural Resources Offices (PENRO) and the Land Management Bureau (LMB) in Mimaropa.

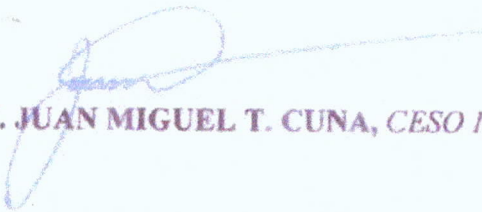
