Please be informed that the accomplishment reports covered the period from March 19, 2023 to April 19, 2023 as the PASu MSPLS required the PA Rangers (Contract of Service) to submit their respective monthly performance report instead of quarterly basis per WFP, CY 2023 as a matter of supervision and prompt response to issues and concerns.

The work accomplishments included among others, seaborne patrolling, LAWIN patrol and mangrove monitoring and surveillance within the jurisdiction of MSPLS. The conduct of regular monitoring resulted in the apprehension of abandoned sets of "hulbot" net in the mid-sea of the Sound, and several paraphernalia used in charcoalmaking.

This is in compliance with our target under the OO1: Natural Resources Conservation and Development Program: PA, Caves and Wetlands Development and Management Sub-Program on Integrated Protected Area Fund (IPAF) with performance indicator "IPAF report submitted (75% PA-RIA and 25% SAGF)."

A total income of Seven Million Six Hundred Sixty One Thousand One Hundred Pesos (Php7,661,100.00) was generated by PAMO ENTMRPA from various fees (certification, entrance/resource use, filming). 
The Executive Committee Meeting was held via Zoom and face-to-face at the Protected Area Management Office (PAMO), CENRO Socorro, Oriental Mindoro. The meeting was attended by eight (8) out of nine (9) PAMB Executive Members and twelve (12) guests. It was presided by MGDH I Raquelita M. Umali from LGU Naujan. Two (2) resolutions were passed in the meeting and to be presented to the PAMB en banc.

Poypoy East with 2.2km long	The PAMO was reminded that opening and construction of new roads are discouraged within protected areas especially with the category of MIBNP as a natural park. The main problem of the farmers at So. Yoga, Barangay Poypoy is the absence of passageway when the nearby river (or creek), as the only passageway, becomes flooded during the rainy season. Hence, the PAMO was advised to open an alternate trail instead of constructing a road to limit access to the protected area and ancestral domains, and minimize disturbance in the protected area.







This refers to the letter dated March 08, 2022 of Atty. Romeo Q. Artazo, Jr., counsel of Ms. Besaga, requesting for a relocation survey on Lot Nos. 4512, 4513, and 4514 in relation to the above-cited case.

Records show that an Order¹ dated December 27, 2017 was issued by then OIC, Regional Director Natividad Y. Bernardino, wherein FLAgT No. DENR IV-MIMAROPA-11302030-0002 was amended to cover only Lot No. 4513, Cad. 860-D, San Vicente Cadastre and excluded Lot Nos. 4512 and 4514.

In the said letter, the request for relocation survey "would enable to determine the specific lots that would be covered by the SLUP of Acosta and that would be retained under the FLAgT of Besaga. Correspondingly, it would determine the structures built in good faith by Besaga on the lots covered by the SLUP of Acosta. Based on the Memorandam(sic), Besaga is entitled to be refunded for necessary and useful expenses with the right of retention."

The above-cited Memorandum being referred to in the letter was issued by the Director, Legal Affairs Service on January 06, 2022 wherein it was considered that Ms. Besaga was a possessor in good faith, and that:

"xxx it is clear that Besaga may be reimbursed for the necessary expenses incurred in the establishment of the bathing business from the time the FLAgT was issued until the time she was made aware that the same should be amended. Likewise, Sps. Acosta have the option to refund Besaga the useful expenses incurred. Should it be possible to remove the useful expenses, Besaga has the option to do so. Thus, the Decisions of this Office, the OP, the CA and the SC should not be disregarded for the reason that Besaga might incur damages, as there are remedies available to her." (emphases supplied)

In this regard, the request of Atty. Artazo should be treated as an ordinary request for relocation survey, i.e. expenses to be shouldered by the requesting party. Moreover, this Office is without

jurisdiction to declare and/or rule on the reimbursement of Ms. Besaga for useful and/or necessary expenses, if any. Said function belongs to the regular court, unless the parties will enter into an amicable settlement regarding the expenses.

Further, per Memorandum dated January 26, 2016 of then Acting Assistant Secretary for Legal Affairs, it is stated that the full implementation of the August 6, 2006 Decision necessitates the:

- 1. Amendment of FLAgT in the name of Emelie Besaga to cover only Lot 4513; and
- Exclusion of Lot Nos. 4512 and 4514 from the coverage of Emelie Besaga's FLAgT and to be covered by the Special Land Use Permit of Spouses Felipe and Luzviminda Acosta which shall be given due course pursuant to DAO No. 28, Series of 2004, as amended.

In compliance thereto, an Order dated December 17, 2017 was issued by then OIC, Regional Director Natividad Y. Bernardino amending FLAgT No. DENR IV-MIMAROPA-11302030 of Emelie Besaga to cover only Lot No. 4513 of Cad. 860-D, San Vicente Cadastre and to exclude therefrom Lot Nos. 4512 and 4514 which pertain to and are covered by the application of Luzviminda Acosta. Moreover, a Notice to Vacate dated August 20, 2020 against Mrs. Emelie L. Besaga was issued by then Regional Executive Director Maria Lourdes G. Ferrer.


