Please see attached CSW report submitted by CENRO Socorro for your reference.



This pertains to your Memorandum dated January 03, 2023 for the submission of the Completed Staff Work (CSW) regarding the status of the reclamation project of the PPA in Calapan Port, Calapan City, Oriental Mindoro.

Relative thereto, please be informed that the PPA is still in the process of completing the requirements for the issuance of the Environmental Compliance Certificate (ECC) and the Area Clearance for their reclamation project in Calapan Port. The said agency expressed that they experience difficulties in completing all the requirements in compliance with the DENR Administrative Order (DAO) 2018-14 (Guidelines on the issuance of Area Clearance for reclamation projects and Proclamation/Special Patents over reclaimed lands) which states that the ECC shall form part of the requirements for the issuance of the Area Clearance and DAO 2022-11 (Amending Section 9.6 of DAO No. 2018-14 or the Guidelines on the issuance of Area Clearance for reclamation projects and Proclamation/Special Patents over reclaimed lands) that gives emphasis on the simultaneous submission of the project description for scoping and a copy of the duly received application for area clearance.

Despite such, the representatives of the PPA reiterated that during the meeting on February 01, 2023 at this Office that they will religiously comply with the provisions of the DAO 2018-14 and DAO 2022-11 to obtain the required area clearance the soonest time possible and implore for the facilitation of our Office.

FACTUAL BACKGROUND

On July 19, 2022, a dialogue with the PPA Mindoro personnel was initiated by this Office to clarify the Area Clearance needed in the reclamation projects of the PPA. It was found that the PPA have no Area Clearance yet for their reclamation projects in Calapan City and Puerto Galera. Hence, they were advised to secure the Area Clearance for their reclamation projects as per DAO 2018-14 (Guidelines on the issuance of Area Clearance for reclamation projects and Proclamation/Special Patents over reclaimed lands) and DAO 2022-11 (Amending Section 9.6 of DAO No. 2018-14 or the Guidelines on the issuance of Area Clearance for reclamation projects and Proclamation/Special Patents over reclaimed lands).

ACTIONS TAKEN

On November 18, 2023, personnel from the Regulation and Permitting Section (RPS) of this Office conducted follow-up activity with the PPA Mindoro regarding their compliance with DAO 2018-14.

Likewise, on January 23, 2023, an ocular inspection was conducted in Calapan Port to determine the status of the reclamation project in the area. Another dialogue with the PPA Mindoro representatives was initiated by this Office on February 01, 2023.

FINDINGS / RECOMMENDATIONS

This Office was informed through a letter by the PPA on December 02, 2022

that they are still waiting for the documents needed for their Area Clearance application which will be released by their Head Office. It was also stated in the said letter dated November 23, 2022 that the Proposed Port Zone Delineation (PZD) of Calapan was already forwarded to the Sangguniang Panglungsod of Calapan for favorable resolution as endorsed by the Sangguniang Barangay of San Antonio through Resolution No. 04, Series of 2022.

Based on the submitted report dated January 26, 2023 by the CENRO Socorro personnel who inspected the reclamation site on January 23, 2023, it was verified that the said project is a foreshore land within Calapan Bay. Likewise, it is adjacent to an Alienable and Disposable (A and D) land within Barangay San Antonio, Calapan City, Oriental Mindoro as per Land Classification (LC) Map No. 4, Project 5 dated November 5, 1920. The on-going reclamation project of the PPA with an area of 2.2 hectares was also verified to be within the proposed PZD of the Calapan Port.

During the meeting on February 01, 2023, the PPA personnel mentioned that they are still in the process of completing the needed requirements for their Environmental Compliance Certificate (ECC) and Area Clearance application while waiting for the authorization from their Head Office. However, the said agency expressed that they experience difficulties in completing all the requirements cited in DAO 2018-14 and DAO 2022-11. Despite such, the PPA personnel reiterated that they will strictly comply with the provisions of the cited DAOs to obtain the required area clearance. They had already coordinated with the DENR MIMAROPA regarding this matter and they also reported that the on-going reclamation project in the Calapan Port is almost 80% completed.

Hence, the undersigned hereby recommends that the PPA Mindoro observe the agreement in the said meeting where they have to submit an Area Clearance application in compliance with the DAO 2018-14 and DAO 2022-11.






