The meeting was held at 3<sup>rd</sup> Floor, Conference Room, Municipal Hall of San Fernando, Romblon.

**Time started:** 10:30 a.m.

**I. PRELIMINARIES**

To begin the 1<sup>st</sup> PAMB En Banc meeting for CY 2023 of Mt. Guiting-Guiting Natural Park, an invocation was given then followed by singing the Philippine National Anthem conducted through Audio Visual Presentation (AVP).

EcoMS I Ms. Nieves F. Penuliar first acknowledged the presence of the representative of DENR MIMAROPA Regional Executive Director, the Municipal Mayors of Magdiwang, and San Fernando, National Agencies representative, Academe, NGOs and POs, Barangay Officials from the seventeen (17) barangays, Protected Area Management Office staff, the OIC Sibuyan Substation and concurrent PASu of MGGNP Manuel B. Romero, members of the secretariat, guests and visitors.

Hon. Nanette B. Tansingco, Municipal Mayor of San Fernando, gave her welcome address. She thanked the PAMB members present during the meeting despite of the heavy rain and bad weather especially in Magdiwang, Romblon. Well in fact, the classes in San Fernando are already suspended due to the bad weather. On the other hand, she was sad because some of the

PAMB members weren't able to attend due to unavoidable circumstances. Nevertheless, she expressed her gratitude of some of the PAMB members that exerted their effort to participate the meeting. She also mentioned that the 1<sup>st</sup> Quarter PAMB Meeting CY 2023 means a lot on their municipality and the whole Sibuyan Island most especially these past few months they had been facing a big battle with regard to the environmental issues in San Fernando. She further stated that aside from discussing the agendas of the meeting, she will initiate to tackle the issue of Altai Philippines Mining Corporation (APMC) after the discussion of proposed agenda. Hon. Tansingco hoped that the activities of the celebration of 27<sup>th</sup> Anniversary Proclamation of Mt. Guiting-Guiting Natural Park will also be discussed. All decisions pertaining to the activities will be very much appreciated since their municipality will be the host of the said celebration and they will try their best for that event be meaningful. She expressed her initiative to protect and conserve the beauty of Mt. Guiting-Guiting Natural Park and the whole island of Sibuyan. Mayor Tansingco emotionally thanked Hon. Arthur R. Tansiongco, as she felt that she had a father on her side especially these past few weeks because issues on the construction of causeway by APMC had been troubling her. Again, she extended her gratitude for Mayor Tansiongco being able to attend the meeting because she felt pity on herself as Mayor Ramos of Cajidiocan wasn't able to make it. His presence in the meeting means that all chief executives, especially Mayor Tansiongco, are always there protecting our island of Sibuyan, Hon. Tansingco stated. She then added that many derogatory words were thrown to us not just about the mining issue but the other issues concerning our environment. Thus she thinks that aside from the proposed agendas, the PAMB should tackle issues to be addressed by the proper agency. Because on the municipal level, there are also limitations on the actions they can implement and the DENR has the greatest part in playing the role in protecting the beautiful island of Sibuyan. That's why the PAMB Members should be united in coming up with a good suggestion and the best solution. Lastly, she once again thanked the PAMB Members especially Hon. Tansiongco for being present during the meeting.

Hon. Arthur R. Tansiongco, M.D., Municipal Mayor of Magdiwang gave his message for the 1<sup>st</sup> Quarter MGGNP PAMB En Banc meeting. He extended his gratitude to Mayor Tansingco for welcoming the PAMB Members in San Fernando. And he mentioned that everything that is about our beloved Mt. Guiting-Guiting Natural Park, he will always be there to give his support. He also hoped that all Brgy. Captains present on the meeting will listen to them as Mayors of Sibuyan Island. He stated that on the past weeks, the Local Chief Executives had been receiving blames from the Sibuyanons regarding the issue of mining in San Fernando and why the nature has been hard for all of the people. To solve this problem, he suggested that the PAMB Members need to think critically and be united together with the heads of each municipality, Mayor Nanette Tansingco of San Fernando, Mayor Marvin Ramos of Cajidiocan and himself for Magdiwang. At the end of his message, he thanked everyone for their participation and he hoped for a fruitful discussion for that day's meeting.

On behalf of the DENR MIMAROPA Regional Executive Director, Ma'am Michaela Rongavilla gave her message for the 1<sup>st</sup> Quarter PAMB En Banc Meeting. She started her message by acknowledging the presence of the Municipal Mayors, PAMB Members and all guests and visitors attending the meeting. She mentioned that the DENR MIMAROPA Regional Executive Director Lormelyn E. Claudio as the MGGNP PAMB En Banc Chairperson, would like to extent her gratitude upon appreciation of every participants attending the meeting. Unfortunately, Ma'am Lormelyn E. Claudio wasn't able to attend the 1<sup>st</sup> Quarter PAMB En Banc meeting because she was attending other pressing matters and issues that need immediate attention and action. For the meantime, Ma'am Michaela Rongavilla together with her staff, Ma'am Fatima Grate, will actively participate on the meeting as observers and resource persons. She also assured that all concerns of every attendee will be noted.

## **II. MEETING PROPER**

### **A. Introduction of PAMB En Banc Members, DENR Staff and Secretariat**

EcoMS I Nieves F. Penuliar as the representative of the secretariat, acknowledged and introduced the members of the board in attendance headed by the representative of the Regional Executive Director Ma'am Fatima Grate, the three (3) Municipal Mayors of Magdiwang, Cajidiocan, and San Fernando, National Agencies, representative of Academe, NGOs and POs, Barangay Officials from seventeen (17) barangays, Protected Area Management Office personnel and members of the secretariat and visitors.

#### **B. Roll call and Call to Order**

EcoMS I Mylene Evallar officially roll-called the attendance of PAMB members from the Regional Office, Offices of the Congressman and Governor, the three (3) Municipal Mayors (Cajidiocan, Magdiwang and San Fernando), Department Heads of National Government Agencies, Non-Government Organizations, Peoples Organizations, Brgy. Local Government Units, Academe and Indigenous Peoples. Out of thirty-five (35) regular PAMB en banc members, nineteen (19) were present; hence, a quorum was declared.

In the absence of the MGGNP PAMB Chairperson Hon. Lormelyn E. Claudio, CESO IV, PASu Manuel B. Romero opened the nomination for the presiding officer of the 1<sup>st</sup> Quarter PAMB En Banc meeting. Hon. Nanette B. Tansingco was nominated by the majority of the PAMB members. Hon. Ramona Rivero moved to close the nomination and seconded by Hon. Rommel Augustus Radan and duly approved by the majority members of the PAMB. Hon. Nanette B. Tansingco was unanimously appointed to be the presiding officer for the 1<sup>st</sup> Quarter PAMB En Banc Meeting CY 2023.

#### **C. Reading and approval of the minutes of the previous meeting (November 08, 2022)**

EcoMS I Mylene Evallar gave the copy of the minutes to all PAMB members present on the meeting beforehand. Thus the presiding officer, Hon. Tansingco asked the PAMB members if they have comments and objections from the 4<sup>th</sup> Quarter PAMB meeting before the approval. Since there are no comments and objections from the 4<sup>th</sup> Quarter PAMB En Banc minutes, Hon. Ramona Rivero moved for the approval of the minutes of the previous meeting and seconded by Hon. Ramonito Gubaton and duly approved by the majority members of the PAMB.

#### **D. Matters arising from the previous meeting**

Hon. Nanette B. Tansingco announced to proceed to PASu report on the agreement reached during the previous meeting.

#### **E. Report of the Protected Area Superintendent (PASu) on the agreement reached during previous meeting.**

PASu Manuel B. Romero reported that the following resolutions numbered from MGGNP-PAMB En Banc Resolution No. 2022-13 to 2022-15 and minutes of the previous meeting dated November 08, 2022 were submitted to the Regional Executive Director/PAMB Chairperson for approval, thru the PENRO:

1. **PAMB Resolution No. 2022- 13, Series of 2022** "A resolution requesting DENR and other government agencies to provide assistance and alternative livelihood to local communities to combat illegal activities and ease poverty;
2. **PAMB Resolution No. 2022-14, Series of 2022** "A resolution requesting the Provincial Government of Romblon for one (1) dump truck that will be used for hauling of apprehended forest products within Sibuyan Island;
3. **PAMB Resolution No. 2022-15, Series of 2022** "A resolution requesting the DENR MIMAROPA Regional Executive Director to allow the issuance of cash ticket for ecotourism activities within Mt. Guiting-Guiting Natural Park;

Re-affirmation of previous resolutions passed during the 2<sup>nd</sup> Quarter PAMB Meeting on May 18, 2022:

1. **PAMB En Banc Resolution No.2022-04, Series of 2022** “A Resolution Approving the Work and Financial Plan for FY 2023 of Mt. Guiting-Guiting Natural Park, Sibuyan Island, Romblon Amounting to Three Hundred Eighty-Five Thousand Pesos (P 385,000.00) Representing the 75% share of IPAF Collection from November 01, 2019 to February 28, 2022 for the Repair of Land Rover.”
2. **PAMB En Banc Resolution No.2022-05, Series of 2022** “A Resolution granting Special Permit to Climb Mt. Guiting-Guiting to Mr. Ramoncito Ruiz and PAMO Personnel to conduct Biodiversity and Trail Safety Assessment.”
3. **PAMB En Banc Resolution No.2022-06, Series of 2022** “A Resolution Requesting ASEAN Ministers of Environment, NCCA and DENR to assist the PAMB in the proposed proclamation of Mt. Guiting-Guiting Natural Park.”
4. **PAMB En Banc Resolution No.2022-07, Series of 2022** “A Resolution Approving the Work and Financial Plan for CY 2022 of Mt. Guiting-Guiting Natural Park, Sibuyan Island, Romblon Amounting to the Three Hundred Ninety – Nine Thousand Five Hundred Pesos Only (P 399, 500.00) Representing 75% Share of IPAF Collection from March 01, 2018 to October 31, 2019 for the Proposed Uniform of DENR Sibuyan Sub-Station and PAMO personnel.

#### F. Approval of the Agenda

Hon. Nanette B. Tansingco, read the agenda to be tackled in the meeting. The Chairperson requested for any movant. Hon. Ornito Ramilo moved for the approval of the proposed agenda. It was seconded by Hon. Jhonny Riano and approved by the majority members of the PAMB.

#### G. Meeting Agenda

##### 1. Reporting of LAWIN patrolling inside Mt. Guiting-Guiting Natural Park

In the absence of Forester Rolly Morales, Forest Ranger Henry Carbonilla II was tasked to report the status of LAWIN patrolling inside the Protected Area. According to Forest Ranger Carbonilla II, PASu Manuel B. Romero instructed the DENR patrollers to conduct strict foot patrolling and surveillance within the Protected Area. PASu Romero distributed all rangers to hotspot areas for the violators be alarmed and to minimize illegal forest activities. On the first week of January, regular employees of DENR went to So. Bangko-Bangko, Brgy. Mabulo, San Fernando, Romblon and monitored the reported illegal small scale mining. The violators allegedly extracted the said mineral with the process called “Balat Lupa”.

Forest Ranger Carbonilla II added that last December 2022, DENR personnel headed by Forest Ranger Mark Adonis Romero went to the area as well and it was reported in the 4<sup>th</sup> Quarter PAMB En Banc Meeting held on November 08, 2022. They have discovered a new landslide at So. Hanggan, Brgy. Mabulo, San Fernando, near the illegal mining site approximately 1,000 sq. meters. Based on their observations, it could be the reason of muddy waters going to the river. Upon mapping, the landslide happened outside the protected area. The affected area is not only in San Fernando but also in Magdiwang, specifically at Brgy. Jao-asan and Brgy. Dulangan. Forest Ranger Carbonilla II showed a map for the PAMB members to visualize where this illegal forest activity took place. As he was showing the map, he stated that luckily the CADT area was not entered by the alleged violators. Forest Ranger Carbonilla II presented the image showing a manmade canal created by the violators. Brgy. Captain of Dulangan, Hon. Joven Rodeo, commented that they already went on that area and that they destroyed that manmade canal a couple of times already. Forest Ranger Carbonilla II agreed and he stated that DENR personnel also destroyed that canal but the violators still managed to recover/reconstruct it. Forest Ranger Carbonilla II also stated that the Protected Area warning signages were destroyed particularly in Brgy. Cantagda, Cajidiocan, Romblon; Brgy. España, San Fernando, Romblon; Brgy. Taclobo, San Fernando, Romblon; Brgy. Mabulo, San Fernando, Romblon and Brgy. Mabini, San

Fernando, Romblon; Brgy. Jao-asan, Magdiwang, Romblon; and Brgy. Dulangan, Magdiwang, Romblon. It shows that violators destroyed the Protected Area Warning Signages intentionally. Forest Ranger Carbonilla II mentioned that there were teams disseminated on the hotspot areas and they were assigned to be there for four (4) days and once they went back to the official station, another group will be staying on the camp as an alternate to guard the vulnerable area against forest violators. Hon. Tansingco asked if the violators were caught on act while doing the illegal forest activities. Forest Ranger Carbonilla II answered that there were alleged person who served as their look out thus they were not caught in the act. Therefore, Hon. Tansingco proposed her idea of creating a task force to help DENR personnel to protect our beloved Mt. Guiting-Guiting. She also requested for them to have the schedule/travel plan of DENR for them to come up with groups to join DENR personnel in monitoring and conduct foot patrolling within the PA. So, Hon. Tansingco moved to pass **PAMB Resolution No. 2023-01, "A Resolution to Create a Task Force Composed of DENR Personnel, AFP, PNP, CAFGU and LGU Rangers to Strictly Conduct Foot Patrolling Within the Hotspot Areas to Prevent Illegal Forest Activities Within The Protected Area"**. It was seconded by Hon. Ramona Rivero and approved by the majority members of the PAMB.

Hon. Joven Rodeo of Brgy. Dulangan, Magdiwang, Romblon wants to know the exact location where the illegal small scale mining took place. Because, as far as he knows, there were Barangays that were not mentioned on the report but the Brgy. Captain knows that there are some illegal small scale mining happening on their jurisdiction. To be specific, Brgy. Agtiwa is one of the area where this illegal forest activity took place. Hon. Rodeo also mentioned that one of the area where the illegal mining takes place is in Brgy. Mabulo, San Fernando, Romblon and he questioned as why their Brgy. Captain still not cooperating with the PAMB members to solve the problem. As per Hon. Rodeo, Hon. Armando Rios of Brgy. Mabulo, San Fernando, Romblon sent letters to him regarding the muddy waters and small scale mining, but when he asked the Kagawad who brought the letters if they went to the area to know the reasons why is that happening, the kagawad couldn't give statement. And these past PAMB meetings, the Brgy. Captain of Mabulo, San Fernando is not attending the said meeting and sends representative instead. Forest Ranger Carbonilla II confirmed that the illegal small scale mining is happening within Brgy. Mabulo & Mabini, San Fernando, Romblon not in Brgy. Dulangan, Magdiwang, Romblon. It's just that Brgy. Dulangan, Magdiwang, Romblon has been affected because the exact area of the illegal forest activity took place near the border line of Brgy. Dulangan and Brgy. Mabulo. Hon. Rodeo then asked Mayor Arthur Tansingco to hire a LGU ranger that resides at Brgy. Dulangan, Magdiwang, Romblon for this matter to be monitored from now and then. Same as Mayor Tansingco of San Fernando, that she needs to hire people residing at Brgy. Mabulo and Brgy. Mabini that knows well the areas where this violators conducting their illegal forest activity. Hon. Rodeo finally added that this suggestion might help to reduce the illegal forest activity within the PA and to avoid any disturbances that it might bring specifically the water contamination.

Hon. Jesse Roda of Brgy. Mabini, San Fernando, Romblon also stated his complain. As some of the alleged violators in their Barangay are doing illegal forest activity right through their water source. This is the main cause why their water is being contaminated. Hon. Roda instructed one of his constituents to monitor and check the area. Based on the result of the monitoring, a violator was caught on the act and run away.

PASu Romero added that after the DENR-PAMO received a letter from Brgy. Mabulo regarding this issue, intensive Patrolling was conducted right away. The problem is that, the violators are always aware of the timing when the monitoring team will arrive. So, PASu Romero asked if the Brgy. of the said hotspot areas can provide an additional manpower to help the DENR personnel to stay on the area 24/7. PASu Romero also informed that some of the DENR personnel cannot focus solely on this matter because there are other of targets and tasks needed to be actioned. Especially right now, that the park rangers were reduced from ten (10) and there were only eight (8) park rangers hired this 1<sup>st</sup> semester. Hon. Tansingco asked why there's a lay off on the park rangers of the DENR Sibuyan Sub-Station. PASu Romero answered that the hiring of Park Rangers is based on the approved Work and Financial Plan 2023. He then stated that one of the

342 park rangers hired became a park attendant. So, in total, there are seven (7) park rangers are hired  
343 that conducts foot patrolling and surveillance against illegal forest activities within the protected  
344 area of around Sibuyan Island.

345  
346 To sum up, Hon. Tansingco of San Fernando and Hon. Tansiongco of Magdiwang agreed that  
347 they will send five (5) CAFGU each from their municipality aside from their LGU park rangers  
348 during operations and surveillance against illegal mining activities. Hon. Tansingco also stated  
349 that they will need the schedule of the DENR patrollers for them to come up with several teams  
350 to man the hotspot areas.

351  
352 In the middle of the discussion, Hon. Ramona Rivero raised her hand and Hon. Tansingco  
353 acknowledged her. Hon. Rivero expressed her gratitude to everyone especially to the DENR  
354 personnel headed by PASu Manuel B. Romero. She said that, even before the proclamation of  
355 Mt. Guiting-Guiting as Natural Park, she really admired the hard work and sacrifices that every  
356 personnel is doing just to protect and conserve our beloved Mt. Guiting-Guiting. She also shared  
357 that she took part in the protection in the past headed by Hon. Arthur Tansiongco and she  
358 congratulate all PAMB members for their participation in protecting Mt. Guiting-Guiting Natural  
359 Park. But now, she was so disappointed for what is happening and she is now hesitant to help the  
360 DENR. She also added that, she reported her relatives who are doing illegal forest activities to  
361 help protecting our island. But then she thinks that, she stole the right of her relatives to provide  
362 needs for their family. She stated that even on her house, everyone can notice how she avoided  
363 buying good lumbers from the forest violators just to show that she embodied being one of the  
364 protector of Mt. Guiting-Guiting. She said that at present, she is furious because of the situation  
365 and crisis that Sibuyan is facing, she felt that only small problems are being prioritize but not the  
366 big issue. At the end of her message she thanked again the PAMB members and she said that she  
367 is proud of the perseverance of everybody.

368  
369 Hon. Tansingco agreed to the sentiment given by Hon. Rivero. Hon. Rivero added that less  
370 fortunate people who partake on the illegal forest activities are being captured and penalized but  
371 not those privileged people who are doing illegal forest activities. She said that this is a challenge  
372 for all of the people who are protecting Mt. Guiting-Guiting which is our protected area and she  
373 just hoped that all people whether they are less fortunate or fortunate, they need to obey the  
374 forest laws. All of these illegal forest activities, just like this large scale mining that is outside the  
375 protected area which specifically is happening in San Fernando.

376  
377 Hon. Tansingco stated that as a previous Municipal Mayor of San Fernando, she knew that some  
378 PAMB Members know that way back 2005 and 2006, the mining company already have  
379 endorsements and then they went on through the process. During this time, the Brgy. Captains of  
380 España & Taclobo, San Fernando, Romblon and Sangguniang Panlalawigan gave their  
381 endorsements. That's why APMC was given MPSA which is the contract between the  
382 government and the mining company. And there were policies stated there that needs to be  
383 followed. The project had been aborted because a CDO (Cease and Desist Order) was issued.  
384 But on year 2022, the CDO was lifted and also the moratorium for mining activities. At present,  
385 the APMC showed that they already have an exploration permit and a lot of people were asking  
386 what LGU of San Fernando did regarding this. Hon. Tansingco mentioned that LGU San  
387 Fernando already passed resolutions opposing the mining activity and not only San Fernando but  
388 also the two municipalities (Cajidiocan and Magdiwang) in Sibuyan. She also wants to make  
389 clear that their resolutions served as sentiments, as it can be actioned or relinquished. Again, she  
390 stated that all of the permits that APMC had were given by the central offices/ Region and that  
391 the activities happening right now is the result of the process that happened on CY 2005 and  
392 2006. As per Hon. Tansingco, LGU San Fernando doesn't have the right to stop the operation of  
393 APMC because it is not their jurisdiction since they (APMC) have all the permits to operate. She  
394 also stated that how can we initiate the operation of APMC to be stopped if the national agencies  
395 didn't asked for the Barangays and LGU San Fernando to provide clearances on their activities.  
396 She also cleared that no permits are given to APMC from their municipality because their  
397 operation right now is not yet considered as business since the APMC is still conducting testing.  
398 But once the exploration was done and found out that the mineral ores are minable, that is the

time when the APMC will ask for business permit to the LGU of San Fernando. And she strongly aforementioned that the issuance of business permit to APMC will be very hard. Once they failed to have the endorsement from the two (2) Barangays (España and Taclobo) and LGU of San Fernando, they will not be able to continue their operation in the area. She added that as far as LGU San Fernando's concern, they are sending letters back and forth to the APMC, DENR, and Philippine Ports Authority (PPA) to compile all information they needed. Until now, they are still worried because APMC already constructed their port without showing any permits from the DENR as a proof that their port construction is legal. Again, she wants to inform everyone that before the National Agencies provide their endorsement to APMC regarding their exploration, they went through a process. The only way LGU San Fernando did with this is that, they passed resolutions opposing the mining during the time of Former Mayor Salem Tansingco together with the two municipalities. To be honest as per Hon. Tansingco, the only way to stop the mining here in Sibuyan is the order from our President Ferdinand Marcos, Jr. Because he is responsible in giving the go signal to a mining company to proceed on their operation. She finally expressed her emotions that, also herself can feel the sentiment of everyone because she is also a Sibuyanon and why are we letting APMC to operate especially right now that we can see they already have violations even if they have exploration permit. Those violations will be a ground for not endorsing APMC in their extraction or mining activity. So she just hoped that everyone will realize that LGU San Fernando is really doing their best to act in a legal and moral way to protect our beloved island. She strongly believed that the illegal forest activities happening right now must be stopped. However, this cannot be opposed without the unity and participation of every Sibuyanon.

## **2. Reporting of Barangay Captains on the status of illegal activities of the Protected Area in their respective jurisdictions**

On the reporting of Barangay Captains on the status of illegal activities of the Protected Area in their respective jurisdiction, Hon. Tansingco asked Hon. Joven Rodeo of Brgy. Dulangan, Magdiwang, Romblon to start. Hon. Rodeo mentioned that he witnessed the some areas of his jurisdiction destroyed because of people doing small scale mining. He asked for the rangers to do their regular patrol specially to their area for it to be stopped.

Next, Hon. Jesse Roda of Mabini reported that those people that destroyed the signages of Mt. Guiting-Guiting Natural Park are those residents that reside near the boundary of the Protected Area. One time, Hon. Roda caught one and he reprimanded him. The man he caught just said, he was destroying it because it was a sign that they could no longer enter the protected area. In a calm way, Hon. Roda explained to him that it is not true and the signage was made to protect the Mt. Guiting-Guiting Natural Park.

Then, Hon. Ornito Ramilo of Brgy. Silum, Magdiwang, Romblon gave his report. He mentioned that within his jurisdiction, the livelihood of his constituents is fishing and especially some of them are from Masbate, since they don't have their own land to source wood from, they are forced to get woods from the timberland just for them to make Casco hulls for their fishing boat. Unfortunately, he said, that some of those people are abusing the taking of wood and getting to a point where they are already selling those Casco hulls to the nearby islands. In response to this, PASu Romero told Hon. Ramilo that he will send his patrollers to man the area and do strict patrolling and surveillance against illegal forest activities.

## **3. Presentation of Study/Research Paper Result of Ms. Andrei Yvonne Ricohermoso entitles "*Land Degradation Vulnerability Assessment Through Soil Erosion Susceptibility within Mt. Guiting-Guiting Natural Park Using Geographic Information System (GIS) and the Revised Universal Soil Loss Equation (RUSLE) Model*".**

Ms. Andrei Yvonne Ricohermoso wasn't able to present her study/research paper result because she had to attend an important meeting. EcoMS I Nieves Penuliar stated that a copy of Ms.

Ricohermoso's research study was given and assured for it to be printed and be provided a copy to each PAMB members for their reference and information.

#### **4. Finalization of Activities for the 27<sup>th</sup> Proclamation of Mt. Guiting-Guiting Natural Park, Sibuyan Island, Romblon.**

EcoMS I Nieves Penuliar presented the proposed activities for the 27<sup>th</sup> Proclamation of Mt. Guiting-Guiting Natural Park. The Board agreed to the activities presented such as the conduct of Communication, Education, and Public Awareness (CEPA) Campaign to schools at San Fernando, Romblon. The schools chosen were Don Carlos Mejias Memorial High School and España National High School at España, San Fernando, Romblon. Initial coordination to the said schools were conducted and the agreed schedule will be on February 1-3 2023. The LGU San Fernando, on the otherhand will provide snacks to the pupils/students during the CEPA activity as their counterpart on the activity. On the proposed coastal clean up, Hon. Mayor Arthur Tansiongco suggested if the coastal clean up can be done simultaneously each municipality of Sibuyan Island on the 14<sup>th</sup> of February instead of the appointed day which is 20<sup>th</sup> of February. The reason is, all Mayors of the Philippines will be having a Mayor's League and they are obliged to attend. Everyone agreed and seconded for all of the municipality have their participation on the celebration.

#### **5. Conduct of Management Effectiveness Assessment (MEA)**

EcoMS I Mylene Evallar provided each PAMB members the MEA questionnaire and guided the them on answering the MEA. In the middle of the discussion, Hon. Arthur Tansiongco suggested if that can be answered by them on their free time since that is time consuming. Everyone agreed to this and EcoMS I Evallar was assigned to collect the questionnaire of all PAMB members once completed.

#### **6. Other Matters**

The president of the Mt. Guiting-Guiting Guides and Porters Association, Mr. Bernar Tansiongco verified if it is true that Camp 2 is temporarily closed due to the clearing expansion that happened during the peak season of mountaineers. Mr. Tansiongco explained that the reason of the expansion is that the area where the campers are allowed to camp was flooded. So, the only way for them to make a rest and set up their camp site was to move the grass on the side which they did and Mr. Tansiongco knows that there's nothing wrong with it.

PASu Romero responded that Camp 2 were never closed for mountaineers and that all of the organizers will be given copy of the policies for their reference. Due to this, Hon. Rommel Augustus Radan requested to have available personnel that will focus on mountaineering activities in MGGNP. PASu Romero answered that he had already hired a park attendant that will focus on the ecotourism activities and mountaineering. Also, Hon. Arthur Tansingco suggested that this matter needs to be discussed with other organizers for them to be aware of the happenings about mountaineering and for them to raise their concerns pertaining to this. Everyone agreed with what Hon. Tansiongco said.

Next, EcoMS I Mylene Evallar read the forwarded letter from the executive producer of news anchor, Ms. Kara David regarding their visit and documentary about Mt. Guiting-Guiting Natural Park. Hon. Rommel Augustus Radan suggested if the PAMB can waive the fees that Kara David's team will be paying because this is a big chance to help our island to become popular to the tourists and to become a well-known tourist destination. Unfortunately, there are policies that are already passed and they are really accountable with the fees needed to be paid.

Thus, Hon. Rommel Augustus Radan moved **PAMB Resolution No. 2023-02 Series of 2023 "A Resolution allowing Ms. Kara David and her team to conduct filming activities in Mt. Guiting – Guiting Natural Park for a documentary"**. It was seconded by Hon. Jhonny Riano and approved by the majority of the PAMB.

**H. Adjournment**

For the next PAMB Meeting, the Board agreed to conduct the 2<sup>nd</sup> Quarter PAMB Meeting on the month of April and the venue will be in Magdiwang. Since there are no other agenda to be discussed, Hon. Ramona Rivero moved to the adjournment, it was seconded by Hon. Ornito Ramilo and approved by the Board.

**A RESOLUTION TO CREATE A TASK FORCE COMPOSED OF DENR PERSONNEL, AFP, PNP, CAFGU AND LGU RANGERS TO STRICTLY CONDUCT FOOT PATROLLING WITHIN THE HOTSPOT AREAS TO PREVENT ILLEGAL FOREST ACTIVITIES WITHIN THE PROTECTED AREA**

**WHEREAS**, it is within the powers, duties and functions of the Protected Area Management Board (PAMB) to approve policies, guidelines, plans and programs, proposals, agreements and other related documents, including the Manual of Operation for the efficient and effective management of Mt. Guiting-Guiting Natural Park (MGGNP);

**WHEREAS**, this department, in partnership with other government agencies prioritizes the welfare of the Filipino people;

**WHEREAS**, during the 1<sup>st</sup> Quarter PAMB En Banc meeting held at San Fernando, Romblon, the issue on small scale mining in various barangays within the Protected Area had been raised;

**WHEREAS**, the issue of mining is believed to be the result of muddy water in the concerned barangays whenever it rains hard;

**WHEREAS**, during the conduct of patrolling/surveillance and investigation, DENR personnel saw evidence of illegal mining activities in certain barangays in Magdiwang and San Fernando;

**WHEREAS**, it was raised by Hon. Joven Rodeo of Brgy. Dulangan, Magdiwang that they had observed continuous illegal mining activities in the boundary of his barangay and he had asked the assistance of DENR for such matters;

**WHEREAS**, the area cannot be patrolled by the DENR personnel alone due to rough terrain and insufficient manpower;

**WHEREFORE**, premises considered after due deliberation and upon motion of Hon. Arthur R. Tansiongco, duly seconded by Hon. Ramona Rivero and approved by majority members of the PAMB of Mt. Guiting-Guiting Natural Park; be it

**RESOLVE** as it is hereby resolve a resolution to create a task force composed of DENR personnel, AFP, PNP, CAFGU and LGU rangers to strictly conduct foot patrolling within the hotspot areas to prevent illegal forest activities within the protected area;

**RESOLVED FINALLY**, that copies of this resolution be furnished the Regional Executive Director, DENR MIMAROPA Region for her approval, concerned Government agencies and PASu, MGGNP for their appropriate action, information and record.




Figure 1. PAMB Members, secretariat and guests during the singing of National Anthem.




Figure 3 & 4. Hon. Arthur Rey Tansiongco during his message.





Figure 5 & 6. Forest Ranger Henry Carbonilla II during his presentation on LAWIN patrolling.




**Figure 10. PAMB Members during the adjournment of 1<sup>st</sup> Quarter PAMB En Banc Meeting of MGGNP.**






