
In accordance with the target of this Office under Operation Against Illegal Environment and Natural Resources Mobilization of Wildlife Enforcement Officers (WEO), please be informed that the undersigned personnel of Monitoring and Enforcement Section conducted the following activities in relation with the afore-mentioned subject target, to wit;

- That on May 02, 2023, the undersigned together with two (2) Forest Protection Officers of Monitoring and Enforcement Section (MES) assisted in the turnover of one (1) long-tailed Philippine monkey (*Macaca fascicularis philippensis*); and
- That the said monkey was brought to DENR Wildlife Rescue Center (WRC) in Barangay Bonliw, Torrijos, Marinduque under the custody of Mr. Elpidio Romasanta, caretaker of said WRC.


Further, this Office sent a letter to all deputized Wildlife Enforcement Officers regarding the submission of their monthly accomplishment report with attached prescribed reporting format for their reference. Be informed that we have no reported illegal wildlife trade for this month.

SUBJECT : TURNED-OVER OF ONE (1) LONG-TAILED PHILIPPINE MONKEY (*Macaca fascicularis philippensis*) IN BARANGAY NANGKA I, MOGPOG, MARINDUQUE

This pertains to the letter of Mr. Jayson de Luna of Barangay Nangka I, Mogpog, Marinduque which received by this Office on April 19, 2023 regarding the surrender of monkey in Barangay Nangka I, Mogpog, Marinduque.

Please be informed that on April 28, 2023, the undersigned together with FPO Jake Valencia and Eduarson Buatis proceeded to Barangay Nangka I, Mogpog, Marinduque to conduct interview, physical examination and gather other pertinent data of the said wildlife.


Based on the interview with Mrs. Clarita de Luna mother of Mr. Jayson de Luna the said monkey was originally came from Sta. Cruz, Marinduque which her son Jayson de Luna rescued and later on took care for seven (7) years. Eventually, the said monkey became wild and Mr. de Luna decided to surrender to DENR PENRO Marinduque for safekeeping.

During the physical observation, the monkey was attempting to bite us. We have no adequate equipment to rescue the monkey. Thus, we decided to call for an assistance to Provincial Veterinarian Office, Boac, Marinduque.


On May 02, 2023, Doc. Eugene Rosal of Provincial Veterinarian came to this Office to inject tranquilizer to the monkey. Likewise, on the same day, personnel of Monitoring and Enforcement Section and staff of Conservation and Development Section brought the monkey in Wildlife Rescue Center (WRC) in Barangay Bongliw, Torrijos, Marinduque under the custody of Mr. Elpidio Romasanta, WRC caretaker.

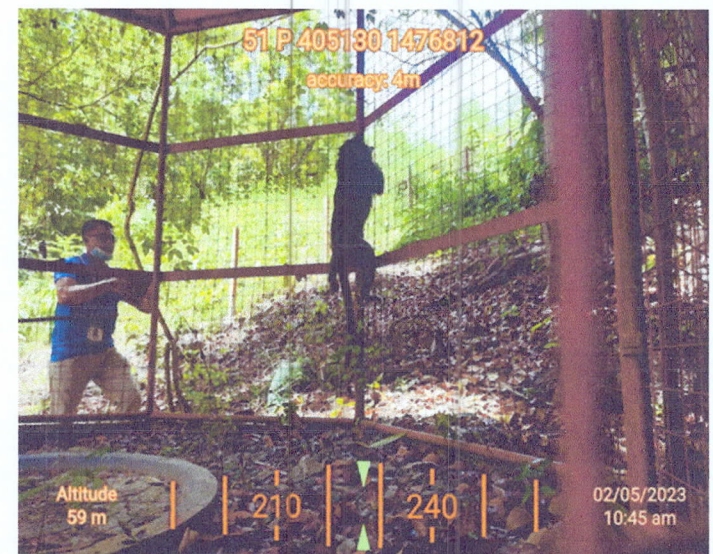
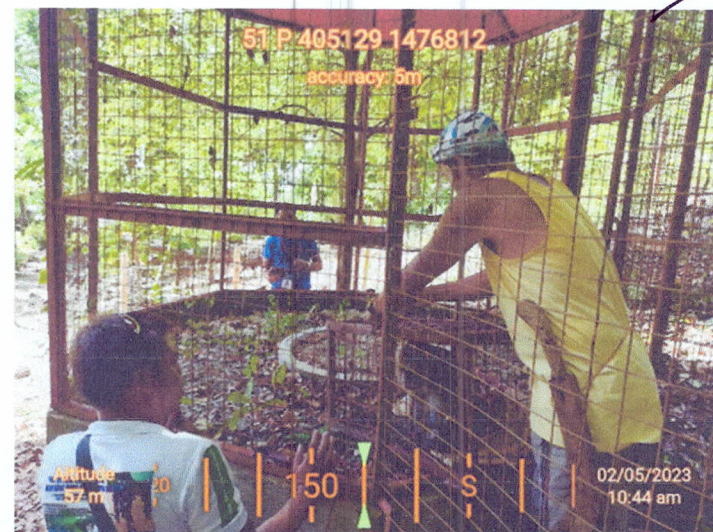
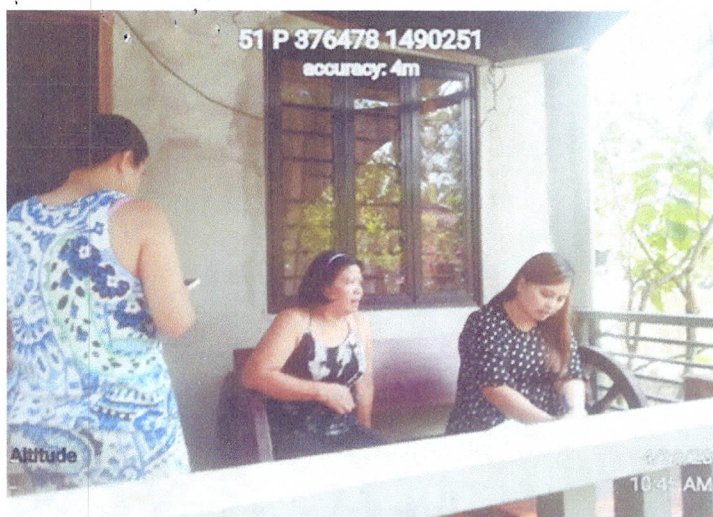
