**I. BACKGROUND**

**WHEREAS**, the Socialized Industrialized Forest Management Agreement (SIFMA) was issued to Mr. Apolinario Del Mundo, Mr. Pastor Villanueva, For. Emeterio M. Recto and For. Jessie Montemayor.

**WHEREAS**, after the compliance monitoring of the Regional Office Enforcement Division and the staff of PENRO Marinduque-Monitoring and Enforcement Section on May 17 to 19, 2022 a show- cause order was issued to Mr. Apolinario Del Mundo, Mr. Pastor Villanueva, For. Emeterio M. Recto and For. Jessie Montemayor on December 13, 2022. Accordingly, the said holders failed to 1) Introduce improvements such as planting of forest trees and non-timber species, fruit trees, and agricultural crops for food production; 2) Submit the required Annual Report/s to the DENR: and 3) Pay the annual rental dues, interest, and penalties since the issuance of agreement on August 31, 2001. The holders were instructed to settle all their obligations in compliance with the terms and conditions of the tenurial instruments or else the agreement will be canceled upon recommendation to the Secretary.

**WHEREAS**, the holders are order to comply with the show-cause order within thirty (30) days upon receipt of the same.

**II. FINDINGS:**

Within thirty (30) days upon receipt of the Show-Cause Order the aforementioned SIFMA Holders area hereby ordered to;

1. To submit written explanation under oath why the lease contract shall not be cancelled for non- compliance with the terms and conditions set forth in the contract;
2. To submit the required Annual Report/s as required in the SIFMA contract;
3. To pay the Annual rental Fee for the use of the land since the issuance of agreement.

**APOLINARIO DEL MUNDO**

All orders stipulated in the Show-Cause Order were not complied by the holder.

**PASTOR VILLANUEVA**

Mr. Villanueva did not introduced new development in the SIFMA area. Majority of the plant that can be seen the area was only Antsoan dilaw. No fruit trees nor agricultural crops within. The DENR also did not received any written explanation as to not the tenurial agreement shall be cancelled. Further, no annual report/s was submitted also however he did coordinate with this Office about the content of



the said report. He did also paid partially his annual dues covering the 6<sup>th</sup> to 10<sup>th</sup> year of the agreement including the 8% surcharge.

**EMETERIO M. RECTO**

For. Recto did coordinate with this Office about all the all the terms that he need to comply. He personally ask about the content of the annual report and ask for the computation of his Annual dues that need to be settled. However, at the present no reports and payment was received by this Office.


**JESSIE S. MONTEMAYOR**

No order stipulated in the Show-Cause were comply by the holder.

**III. RECOMMENDATIONS:**

In view of the content of the Show-Caused Order considering that the thirty days had gone past after the receipt of the same by the Holder, the following are hereby recommended, to wit;

1. That the SIFMA area of For. Jessie Montemayor and Mr. Apolinario Del Mundo be cancelled citing the non-compliance with the Show-Cause Order.
2. That the contract of Mr. Pastor Villanueva and For. Emeterio Recto be considered until the Performance Evaluation on CY 2024 considering that one has partially paid his annual dues and both are interested to renew their agreement, however they need to settle all their responsibilities before the expiration of the SIFMA contract.

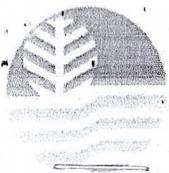

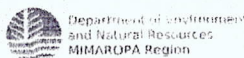

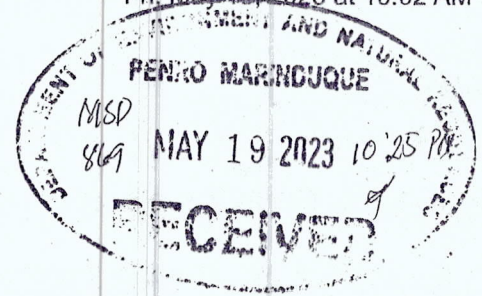
