Please find attached inventory sheet following the prescribed template for you reference and record.

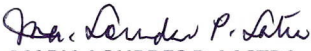

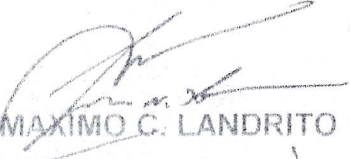
