The Forest Management Bureau is mandated to provide technical guidance to the DENR Central and field offices in the effective protection, development, and conservation of forestlands and watersheds, and to recommend policies and programs towards the achievement of sustainable forest management, based on science and principles of good forest governance.

As part of this mandate and to ensure the effective implementation of forestry-related laws, rules, and regulations, the Bureau developed a series of videos to discuss several issues and concerns pertaining the forestry sector. The said video series was packaged in a Forestry 101 Talkshow format and aimed to provide clarifications and discuss frequently-asked questions being raised by the DENR Field Offices in terms of forest policy implementation, particularly on the following topics:

1. Forestry Tenurial Instrument Requirements
2. Tree Cutting Permits
3. Tenure Fees
4. Mapping Requirements on Tenure Applications
5. National Greening Program.
