This refers to the letter of Ms. Marianne Arlene S. Bodegas concerning Lot Nos. 478 and 479, Pls 395 located at Cambunang, Bulalacao, Oriental Mindoro.

Be informed that the matter was referred to CENRO Roxas. Hence, CENRO Roxas submitted Completed Staff Work (CSW)¹ report clarifying all the queries of Ms. Bodegas mentioned in her letter² dated November 15, 2022.

Further, this Office instructed CENRO Roxas to send a representative to attend on the dialogue meeting on December 12, 2022 at Cambunang, Bulalacao Oriental Mindoro requested by Ms. Bodegas. Based on the report³ submitted by LMO II Rodel M. Montealegre, no one among the farmers/occupants of the said lots arrived and even Ms. Bodegas did not attend.

Furthermore, on January 25, 2023, a letter⁴ from Ms. Bodegas was received at PENR Office requesting for a copy of Resolution issued by DENR Regional Office and this was replied thru a letter⁵ dated January 26, 2023 informing Ms. Bodegas that she may secure the copy of said Resolution at CENRO Roxas.

RECORDS VERIFICATION

The land subject by this letter is known as Lot Nos. 478 and 479, Pls-395 covered by DENR Case No. 5445 & ADR Case No. 2022-1752040-0217 and located at Cambunang, Bulalacao, Oriental Mindoro.

On August 9, 1993 a Resolution was signed by Regional Executive Director, Antonio G. Principe over the DENR Case No. 5445 entitled "Insular Government Property Sales Application (I.G.P.S.A.) No. 1604 and 1605 of Pedro Solis (deceased) now his Heirs, rep. by Pancho A. Solis, Claimant-Protestants -versus- Sangguniang Barangay of Cambunang Bulalacao, Oriental Mindoro rep. by Renato de Guzman, claimant-Protestant -versus- F.P.A. No. (III-12)106 of Aquilino de Leon, and Pablo Baculinao, Jr. (deceased) now his Heirs, rep. by Elmo Baculinao, Applicants-Respondents" with the dispositive portion of which reads as follow;

"NOW THEREFORE, with the foregoing facts and discussions on the matter the herein case is, as it is hereby, RESOLVED in the manner provided, as follows: the (I.G.P.S.A.) application Nos. 1604 and 1605 of Pedro Solis (deceased) now represented by his Heirs over Lot Nos. 478 and 479 is, as it is hereby, GIVEN DUE COURSE taking into consideration those areas already adjudicated to other persons in the Orders previously issued. The Free Patent Application of Aquilino de Leon under F.P.A. No. (III-12) 106 is, as it is hereby REJECTED and the same DROPPED from the rolls, the application of Pablo Baculinao, Jr. (deceased) now represented by His Heirs is, as it is hereby also REJECTED and the same DROPPED from the rolls; the REQUEST CLAIM of the Barangay (Cambunang) for a barangay site and open space for their use is, as it is hereby SET ASIDE as the same is not proper in the premesis, however, with the instruction that the same be referred to the CENR Office for another site identification and further action."

A certification signed by Regional Executive Director, Wilfrido S. Pollisco dated June 9, 1994, stating that no Motion for Reconsideration/Appeal has been filed on the said Resolution. Hence, the same had become Final and Executory.

Memorandum dated December 13, 2017 signed by OIC, Regional Director, Natividad Y. Bernardino, CESE directing this office to implement the Resolution dated August 9, 1993 which this office complied. The execution of order was conducted on December 5, 2018 because the parties involved only complied on that day for, they have many reasons in attending the said invitation.

On March 18, 2022, the Heirs of Pedro Solis undergo ADR proceedings for some issues/conflict arose during the disposition of their land. They come up for an amicable settlement on March 24, 2022 and an Order of Amicable Settlement was issued on September 6, 2022 and signed by In-Charge, PENRO Oriental Mindoro, Alma E. Gibe.

GROUND VERIFICATION

The area is now in the center of Barangay Cambunang, Bulalacao, Oriental Mindoro. Some portions of the area were utilized as rice/onion fields, residential area, school, church and some government facilities.

The entry of the people in the area was based from the purchased from Mr. Elmo Baculinao and some of the claimants protested the IGPSA of Mr. Pedro Solis, and they have the knowledge of the status of the land and very aware of the consequences of the outcome of the case because it is a public knowledge in the barangay that the land is covered by a case. When the resolution comes out, during a meeting in the barangay hall of Cambunang with LGU of Barangay Cambunang rep. by Captain Alma Nool, together with Engr. Eleanette Dayanghirang, Bulalacao LGU rep. by Municipal Assessor Regin Dimaano, and authorized representatives in this office, it was agreed that a subdivision survey be conducted for the proper disposition of the land, some of the occupants willingly agreed and will pay the land they occupied with the heirs of Pedro Solis. The LGU of Bulalacao, Oriental Mindoro willingly agreed to paid the site of the school area by paying the service of the Geodetic Engineer, Engr. Dayanghirang.

OBSERVATIONS

On the letter of Ms. Bodegas she wants to clarify the following:

- 1. Batay sa naisumiting aplikasyon ni Pedro Solis taong 1936 sya ay aktwal na nakaposisyon sa nasabing lupang sakahan, nagkaroon ng disisyon na pinal ngunit pina-ulit hanggang sa ito ay naglapsed; Kung naglapsed na ang itinakdang panahon para sa nasabing aplikasyon bakit nanatiling nagpakilala si Pancho Solis na sya and may-ari ng nasabing lupang sakahan?
- 2. Sa nakasaad sa nasabing resolution hindi ko nakita na nakasaad na ang binigyan ng Karapatan ng ahensyang may saklaw ay si Pancho Solis, na mangulekta ng milyong halaga ng salapi mula sa mga magsasaka, sapilitang nagpa-alis ng mga aktwal na nagsasaka sa nasabing lupang sakahan at nanakot sa mga aktwal na nakaposisyon, sinamantala nya ang kakulangan ng kaalaman ng mga magsasaka para sila ay dayain, lukuhin; Tanong bibigyan pa rin ng ahensyang due course and aplickasyon ni Pedro Solis? (Kalakip po ang kasunduan ng bayaran ng pera na kinulekta ni Pancho Solis)
- 3. Batay na rin sa ginamit na batayan ng aplikasyon Act. No. 3038 na may provision of Act No. 2874 na may aktwal na pagkultiba/pamomosisyon, sa pagkakataong ito simula ng masumiti ang nasabing aplikasyon walang pamomosisyon o pagkultiba mula sa aplikante kundi and pananamantala ng mga aktawal na nakaposisyon aktwal na nagsasaka, Ano ang maging kaparusahang igawad ng ahensyang may saklaw sa pananamantala ng aplikante o nagpapakilalang may-ari ng lupaing hindi naman pala totoo?
- 4. Sa kasalukuyang sitwasyon, sino ang mas higit na bibigyan ng pagkakataong magkaroon ng titulo sa public land yong aktwal na nagsasaka o yong aplikasyon na nanamantala?

Answer for No. 1- It is very clear in the Resolution dated August 9, 1993, that on records of the case it shows that Pedro Solis filed his Insular Government Property Sales Application (I.G.P.S.A.) on October 10, 1936 over two (2) parcels of land under his Tax Declaration No. 336 and 390 with an approximate total area of 40.0000 hectares. Prior to his application, Mr. Solis occupied and cultivated the area starting from the year 1920 which he utilized as grazing land and planted some seasonal crops and other plants. But it was temporarily stopped and was forfeited by the Commonwealth of the Philippines against Mr. Pedro Solis under Criminal Case No. 2057 sometime in 1935.

Because of the forfeiture of the land, it became private property of the Commonwealth of the Philippines, disposable only through Sales or Lease to qualified persons as provided for under Act No. 3038. It is for this reason and his desire to have the land back in his possession that Mr. Pedro Solis filed his I.G. P. S. A. application over the two (2) parcels of land. He paid for and perfected his application on November 5, 1936 in the Manila Office of the Bureau of Lands and the same was given due course.

Answer for No. 2- The collection of money between Mr. Pancho Solis, representative of Heirs of Pedro Solis and some farmers is out of our control. Also, it is not stated in the Resolution, thus, any conflicts arose on such collections of money is out of the jurisdiction of this office. In regards with the application of Mr. Pedro Solis (deceased) now his heirs, this office will follow and execute the Resolution because it is final and executory and the heirs already agreed amicably on how to dispose the land.

Answer for No. 3- As stated on the answer for No. 1, 2nd paragraph which is self-explanatory. It is already paid and perfected by the original applicant but he had to answer all the number of claims over the land which he waited for resolution until he died in 1974 without seeing the light. How can we question the significance of the final resolution that took for almost half of a century.

It is very clear in the records that the heirs rep. by Mr. Pancho Solis deliberately following up the order of this case and when the time come and everything was favored to them, a mere letter from a Provincial Coordinator Magsasaka Party List, Marianne Arlene S. Bodegas stating that the Heirs of Pedro Solis have no rights over the land which they fight from 1936 up to this time?

Answer for No. 4- Who had the better right? The Heirs of Pedro Solis or the actual occupants who entered the land in good faith or bad faith? As we can see in the attachments of the letter of Ms. Bodegas, the "Sinumpaang Salaysay" of the actual occupant wherein they entered the land in questions from Mr. Baculinao which is the same who opposed with the application of the deceased Pedro Solis.

As stated in the page 4 and 5 of Resolution dated August 9, 1993, it is very clear that Pedro Solis has the right to own and acquire the lands because the alleged transfers of the subject land is not valid that means without force and effect which is submitted by the protestors Aquilino de Leon and Pablo Baculinao as evidence to substantiate their respective claims. The significance of these documents can not be overlooked as they represent the very source of all the so-called series of transfers from which the rights of the other claimants emanate. The records shows that the documents/deeds were all executed and perfected in the year 1975 while Mr. Pedro Solis met his demise sometime in 1974.

The mother instruments having been discredited and declared as not competent evidence of the subsidiary and subsequent Deeds emanating from these originals will therefore surely fail and suffer the stigma of doubt.

The actual occupants representing by Ms. Marianne Arlene Bodegas were the one who benefited and were given the better attention which resulted in the diminution of the original total area of the subject land. They improved the land, yes, but they are also the one who benefited from it, while the original claimant and his heirs fights their rights and waited for the final order of the case.

The original applicant, Mr. Pedro Solis paid and perfected his application on November 5, 1936, he and his heirs battled their rights on the land from 1936 up to this date. As the holder of such sales application and/or claim to this writing can be presumed of private ownership. On the part of Ms. Bodegas, using Magsasaka Party List and giving false hope to the farmers cannot probably outlive the sentiment of private persons long denied of good governance, for it is truly the state at the instance of DENR who can uphold and protect the right of private persons.

RECOMMENDATION

Considering the above-circumstances, it is hereby recommended that Ms. Marianne Arlene Bodegas must submit substantial evidence in claiming such land, and submit necessary documents as stated in DAO 2016-31. Further, it is also recommended that the Order of Amicable Settlement between the Heirs of Pedro Solis be executed in order to exercise social justice.

RESOLUTION

Submitted for resolution before this office is the case involving the claims of the Heirs of Pedro Solis. Aquilino De Leon, Heirs of Pablo Baculinao, Jr. and the Barangay of Cumbunang, Bulalacao, Criental Mindoro over Lots Nos. 478 and 479 of Pls-395-D which is more particularly identified as the area covered by the Insular Government Property Sales Application (I.G.P.S.A.) Nos. 1604 and 1605 in the name of Pedro Solis.

Records of the case shows that Pedro Solis, now deceased, filed his Insular Government Property Sales Application (I.G.P.S.A.) on October 10, 1936 over two (2) parcels of land under his. Tax Declaration No. 336 valued at P 615.36, and Tax Declaration No. 390 valued at P 1,200.00 with and approximate total area of 40.000 hectares with the following boundaries, North by Amamajo Creek: East by property of Eliseo Cabagay: South by property of Quintin B. Cay and West by the Cawacat River. The corresponding application was forwarded to the Bureau of Lands-Office in Manila for further action, which up to this date has not been properly acted upon.

Prior to this application of Mr. Pedro Solis. the land in question was the subject of his occupation and cultivation starting from the year 1920 went he first set foot on the same. The same records reveals that the area was first utilized by the claimant as grazing land and subsequently planted to with some seasonal crops and other plants. Such possession and occupation of the land by Pedro Solis was temporarily stopped when the same was forfeited by the Commonwealth of the Philippines by virtue of a Writ of Execution over the area as a consequence of a Penalty imposed

upon Pedro Solis in a Court Case filed against him in Criminal Case No. 2057 for illegal possession of dynamite

The forfeiture of the land subject of the write made the same private property of the Commonwealth of the Philippines, disposable only through Sales or Lease to qualified persons as provided for under Act No. 3038. It is for this reason and his desire to have the land back in his possession that Mr. Pedro Solis filed his I.G.P.S.A. application over the above-mentioned parcels of land.

Having paid for and perfected his application on the same was given due course. Thus, on December 7. 1936, the Director of Lands directed the District Land Officer of Calapan. Oriental Mindoro to conduct a preliminary application of the land covered by the described submitted on time for reason that during all those times a number of claims over the same area were received by the District Office which needed immediate resolution. Thus on Mindoro forwarded to the Director of Lands in Manila the investigation report of Junior Public Land Inspector same.

From 1940 to October 6. 1950 no concrete development were recorded in connection with the case, save for the constant follow-ups of the applicant of his claims to which the Chief, Public Lands Division replied with an Order for him to apply for an I.G.P.S.A. a thing that he has already longs complied with, and for the local lands office to investigate and appraise.

The land in question was not without any other problem during the years that followed while the same was pending in the lands offices concerned. There were a number of claims that cropped out like the claims of the Heirs of Agapito Boyo which was resolved amicably as per the Order issued November 26, 1937. There was also the claim of Vicente Magallanes, the resolution of which was contained in asimilar Order dated June 30, 1940. In May 1, 1956 the most controversial problem of them all that came across this particular land came about when Mr. Pedro Solis wrote a letter to then President Ramon Magsaysay about the intrusion into his land of one Antonio Mallen. He reported that the said fellow has introduced some improvemnts therein and that he has also Tax Declared the same in his own name. The question, however, was resolved by the withdrawal of Antonio Mallen of his claim in an affidavit dated April 27, 1959 he executed for the purpose. An Order was likewise, issued on January 19, 1961 deciding the issues and clearing the claim of Pedro Solis with regards that of Antonio Mallen. It is worthy to note, that in this series of problems that beset the claim of Pedro Solis, all the Orders issued in connection with these case are one in saying that the IGPSA of Fedro Solis can be given further due course.

On April 4, 1963, the Chief, Legal Division informed the Chief, Land Management Division by way of a letter that the Orders dated June 30, 1940 and January 19, 1961 giving due course to the IGPSA application No. 1604 of Pedro Solis over lands at Cawacat, Bulalacao, Oriental Mindoro has become final and executory. A series of follow-ups made by the claimant, as well as, letter from the Bureau of Lands in Manila to the Calapan Office and vice versa were recorded during the the period. Thus, on July 24, 1967, the Chief, Legal Division once again, wrote a letter adressed to the Chief, Land Management Division reiterating the finality and executory nature of the two (2) above-mentioned previous Orders and further giving due course to the application of Pedro Solis.

Giving due course to the application, a request for investigation and appraisal of the land in question was made and on September 26, 1968. Land Investigator Damaso G. Evora submitted his report on the matter. The corresponding assessment of the area was also made by the Municipal Treasurer of San Pedro (now Bulalacao) Consorcio Z. Ampara. Mr. /Pedro Solis was advised to pay the assessed value of P 630.00 and the provisional permit fee of P 20.00, both of which he complied with as evidenced by the Official Receipts Nos. 911408 dated November 5, 1968 and 632573 dated March 8. 1949. respectively.

Mr. Pedro Solis, the original applicant and claimant under IGPSA Nos. 1604 and 1605 died in 1974 due to old age without seeing the light, so to speak of his above application.

For quite sometime the representatives of the claimant, have been following-up the case, which up to now has not-yet been finally decided. Thus, on November 11, 1976, the Chief. Claims and Conflict Section of the Bureau of Lands in Manila wrote a letter addressed to the District Land Officer of Roxas. Oriental Mindoro to conduct further investigation on the subject matter to ascertain the true and correct facts obtaining in the premises due to the conflicting reports and recommendations already submitted.

And for the nth time the District Land Officer of Roxas. Oriental Mindoro requested for certified copies of the the records of the case from the Bureau of Lands Office in Manila on March 18, 1976 and August 27, 1977 to which the Chief of the Records Division willingly responded to in March 3, 1977. During the interregnum, no action was forthcoming however, because on May 16, 1991 after constant follow-ups by the Heirs of Pedro Solis and after the lapse of about two (2) decades, again the CENR Office of Roxas, Oriental Mindoro requested for certified copies of the very same records already forwarded to the local office in the above-noted case. Two (2) days earlier a Protest was submitted by the residents of Cambunang, Bulalacao, Oriental Mindoro, represented here by Leopoldo Panum, Renato De Guzman, Serapio Galos and Romualdez Cabrillos, against the Application for Free Patent of Aquilino De Leon and Pedro Solis under FPA-III-12-106. Lot No. 479, FIS-395-D and FPA-9-2585, Lot No. 478, PIS-395-D, respectively.

The investigation of the case was assigned to Hearing Officer Leon A. Abad of the CENR Office at Roxas, Oriental Mindoro. Investigation and hearing were made and set immediately with all the parties properly represented. An ocular inspection of the subject area was also made on August 17, 1991. Land Management Officer III/Hearing Officer Leon A. Abad submitted his report on October 7, 1991, which was also forwarded to the regional office for proper evaluation and appropriate action.

The significance of a final resolution of this particular case can not be over emphasized because of the length of time that it took for this question to finally reach its conclusion. Half of a century in the waiting is no joke especially if one who ardously waged battle to claim and possess the subject land is not fortunate enough to see its conclusive end. Death has intervened in the meantime, during the pendency of this case and no amount of worldly restitution is better than to put to rest the whole proceedings as do the original parties of this case in their own respective graves.

Going over the records of this case will reveal that this has dragged on for years due to the indecisiveness of those tasked to act on the same. It is also clear that other claimants and pretenders to the land were the ones who benefited and were given the better attention which resulted in the diminution of the original total area of the subject land. The question now, is however, not the old issues attached to the original claim, but rather new and collateral in nature. To be resolved now is the claims of the Sangguniang Bayan of Cambunang, the claims of Aquilino De Leon and that of Pablo Baculinao which are all opposed to the I.G.P.S.A. Nos. 1604 and 1605 of, now deceased, Pedre Solis, which was filed in October 10, 1936 over an area of over 40 hectares.

The actual resolution of this case is not at all that difficult as the issues can be limited to only two (2); First, in the issue of whether or not Pedro Solis has the right to own and acquire the land as per his I.G.P.S.A. application, and Second, whether the alleged transfers of the subject land that took place valid and with force and effect or not. The answers to these two issues will definitely resolve the other collateral issues currently besetting the

Going over the documentary evidences of the parties submitted to substantiate their respective claims we came upon three particular papers worth discussing in this case. Foremost of these documents is the alleged "Affidavit of Quitclaim" dated February 15, 1975 executed by Claimant Pedro Solis in favor of Antonio Mallen, his ertswhile adversary in this case. Another is the submitted "Deed of Absolute Sale" dated March 4, 1975 executed by Antonio Mallen in favor of Pablo F. Baculinao, Jr. which was sanctioned and ratified in the same instrument by Claimant Pedro Solis. The "Contract to Divide Lot No. 479, Pls-395-D", by and between Claimant Pedro Solis and Claimant Aquilino De Leon dated August 18 1975 is also cited here. The significance of these three "Deeds" can

not be overlook as they represent the very source of all the so called series of transfers from which the rights of the other claimant emanates. The efficacy and/or validity of these conveyances will undoubtedly bear upon the ultimate of the rights of the parties in this case. Taking this as a basis for the resolution of the case is a sound judgment considering that it will determine once and for all the respective rights of the parties. The question that may be asked therefore is whether or not the above-mentioned Deeds were all validly executed and thus have force and effect. To this we answer in the negative as the records will show that Claimant Pedro Solis met his demise sometime in 1974, while the above Deeds were all executed and perfected in the year 1975. It is out of this world to have the dead rise from the grave to sign and execute an instrument against his own interest. It is also said that the dead tell no lies and this particular case is a classic example.

The mother instruments having been discredited and declared as not competent as evidence the subsidiary and subsequent Deeds emanating from these originals will therefore surely fail and suffer the stigma of doubt. Questioned documents have no place in this proceedings as they prove nothing but the futility of the case being pursued by the proponents and the resort to artificialities is the sign of resign and hopelessness. Worth mentioning is the disregard of the technicalities of the law with regards to the execution and recording of the instruments in the Notarial Books of the Notaries in this case.

With the issues of the alleged conveyances made in favor of the other parties to the case cleared and resolved, we now move on to the other issue of the present claim by the Barangay of Cambunang. Priority is the issue to be addressed in this particular aspect of the case as the claim of the Barangay is a new and recent addition to the already ages old case of the 1930's. The resolution of the IGPSA issue must first be made before any question on new issue can be tackled. The claim that the needs of the Barangay takes is not well placed as there is nothing to talk about had the present case been earlier resolved and terminated. The only reason why the Barangay was able to come into the picture is the case took over half a century to decide. The Barangay using its public personality is now trying to impose its will upon the rights of private persons long denied in the process. The respect of private rights must be upheld and protected with no less than the State and its instrumentalities taking the lead.

NOW THEREFORE, with the foregoing facts and discussions on the matter the herein case is, as it is hereby, RESOLVED in the manner provided, as follows; the I.G.P.S.A. application Nos. 1604 and 1605 of Pedro Solis (deceased) now represented by his Heirs over Lots No. 478 and 479 is, as it is hereby, GIVEN FURTHER DUE COURSE taking into consideration those areas already adjudicated to other persons in the Orders previously issued. The Free Patent Application of Aquilino De Leon under F.P.A. No. (III-12) 106

as it is hereby REJECTED and the same DROPPED from the coils; the application of Pablo Baculinao, Jr. (deceased) now represented by his Heirs is, as it is hereby also REJECTED and the same DROPPED from the rolls; the REQUEST/CLAIM of the Barangay (Cambuneng) for a borangay site and open space for their use is, as it is hereby SET ASIDE as the same is not proper in the premises, however, with the intruction that the same be referred to the CENR Office for another site institution and further action.



It may be recalled that this Office instructed you to send a representative to attend in the scheduled dialogue meeting on December 12, 2022 at Barangay Cambunang, Bulalacao concerning the same lots. Please provide status update / report on the said attendance considering that the concerns of Ms. Bodegas on the said harassment was done on same date.

On the other hand, in the Completed Staff Work (CSW) dated December 13, 2022 prepared by SI Marie Anne F. Galit duly attested by LMO II Peterson F. Fabellon, she clarified the series of questions concerned by Ms. Bodegas, and further recommended that Ms. Bodegas shall submit substantial evidence in claiming such lands, submit necessary documents as stated in DAO No. 2016-31¹, and the Order of Amicable Settlement between the Heirs of Pedro Solis be executed in order to exercise social justice.

In this regard, please coordinate directly with Ms. Bodegas and advise her to submit substantial evidence to support their claims over the lands and submit necessary documents as stipulated in DAO No. 2016-31.
