COMPLETED STAFF WORK REPORT ON THE APPREHENDED ONE UNIT RUSI CHARIOT BEARING ENGINE NO. RW162FMKVCD26483 AND CHASSIS NO. RWCLHKV4MPO26483 AND THREE PIECES OF UNDOCUMENTED MOLAVE DOOR JAMB AT BARANGAY TAYAMAAN, MAMBURAO, OCCIDENTAL MINDORO FOR VIOLATION OF PD 705 AS AMENDED BY EXECUTIVE ORDER NO. 277 AND REPUBLIC ACT NO. 7161 AND DEPARTMENT ADMINISTRATIVE ORDER 97-32, SERIES OF 1997

#### I. HISTORY/ BACKGROUND

This is in relation to the Administrative Case No. 2021-08-04-16B for Violation of Section 77, PD 705 as amended by RA 7161 and DAO 97-32 series of 1997.

The case was filed against Mr. Ron Jacob Morente, a resident of Barangay Payompon, Mamburao Occidental Mindoro.

That on July 14, 2021, the Quick Response Team Leader, Forest Ranger Noel V. Salgado conducted patrolling together with his team, FPO Vincent V. Urbano, FPO Noelito Badeon and FPO Lorenzo Granados along So. Tuguilan National Road, Barangay Tayamaan, Mamburao, Occidental Mindoro when they spotted a blue RUSI Chariot without plate number carrying 3 pieces Molave door jamb.

The said illegal forest products and conveyance were brought to DENR-CENRO Sablayan Coordinating Office at Mamburao Occidental Mindoro for proper inventory and documentation. Inventory receipt and seizure receipt were issued together with other documentation.

On August 4, 2021, the administrative hearing for the above apprehended illegal forest products was held at the DENR-CENRO Sablayan Coordinating Office. Forester II, Chief EMS, Ariston SJ. Ramos facilitated the hearing. The accused was present and was given the chance to explain himself.

#### II. OBSERVATION/FACTS

- 1. That on July 14, 2021, the Enforcement and Monitoring Section personnel of DENR CENRO Sablayan Coordinating Office in Mamburao, Occidental Mindoro conducted patrolling and monitoring activity at Barangay Tayamaan, Mamburao, Occidental Mindoro. At around 11:09 AM, the team encountered and apprehended one unit RUSI Chariot loaded with undocumented forest products.
- 2. That upon verification, the driver/operator failed to present legal documents or pertinent papers to accompany the transport of 3 pieces molave door jamb. The DENR CENRO Sablayan Monitoring and Enforcement Personnel conveyed the one unit of RUSI Chariot with chassis no. RWCLHKV4MPO26483 and bearing engine no. RW162FMKVCD26483 together with the operator/driver Mr. DENR CENRO Sablayan Coordinating Office in Mamburao, further verification and proper disposition.
- 3. That the corresponding apprehension receipt was issued by the apprehending officer of DENR-CENRO Sablayan Coordinating Office in Mamburao, Occidental Mindoro with CENRO Control No. CSO31-07-04-14-2021-MCO last July 14, 2019.

- 4. That the apprehended one unit of RUSI Chariot with chassis no. RWCLHKV4MPO26483 and bearing engine no. RW162FMKVCD26483 loaded with 3 pieces molave door jamb was temporarily impounded at DENR CENRO Sablayan Coordinating Office in Mamburao, Occidental Mindoro for safe keeping.
- 5. That after verifiying the existence of a prima facie case against the offender, CENRO Officer Engr. Caesar E, Quebec, seizure officer of DENR-CENRO Sablayan Coordinating Office issued the Seizure Order with CENRO Control No. CSO31-07-04-14-2021-MCO for the apprehended one unit of RUSI Chariot with with chassis no. RWCLHKV4MPO26483and bearing engine no. RW162FMKVCD26483 loaded with 3 pieces door jamb.
- 6. That the notice of administrative hearing was issued to the respondents Mr. Ron Jacob Morente with the scheduled set on August 4,2021 at DENR CENRO Sablayan Coordinating Office in Mamburao, Occidental Mindoro.
- 7. That during the administrative hearing of the respondent Mr. Ron Jacob Morente admitted that the forest product caught in his possession has no permit.
- 8. That there was a proof of undocumented forest product caught in the possession of the accused.
- 9. That during the administrative hearing of Mr. Ron Jacob Morente stated that the said conveyance used was owned by his father Ronnie Morente.

#### III. SUMMARY OF ADMINISTRATIVE PROCEEDINGS

It appears that on the administrative hearing conducted on the offender, it was clearly show that the accused in this case violated Presidential Decree No. 705 known as the Forestry Reform Code of the Philippines, as amended by Executive Order No. 277 and Republic Act. 7161.

The grounds for apprehension and seizure of the forest product is valid as to the possession and transporting of forest products during the time of apprehension is not supported with valid/or legal documents as authorized by the law.

Presidential Decree No. 705, May 19, 1975 revising Presidential Decree No. 308 otherwise known as the Forestry Code of the Philippines as amended by Executive Order No. 277 and Republic Act 7161, stated that;

SECTION 77. Cutting, Gathering, and/or Collecting Timber, or Other Forest Product without License.- Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable and disposable, public land, or from private land, without any authority, or possess timber or other forest product without legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Article 309 and 310 of the Revised Penal Code.

SECTION 77-A. Administrative Authority of the Department Head or His Duly Authorized Representative to Order Confiscation. In case of violations of this Code or other forest laws, rules and regulations, the Department Head or his duly authorized representative, may order the confiscation of any forest products illegally cut, gathered, removed or possessed or abandoned, and all conveyances used either by land, water or air in the commission of the offense and to dispose of the same in accordance with pertinent laws, regulations or policies on the matter.

#### IV. RECOMMENDATION

Based on the above statement of facts and the administrative hearing conducted last August 4, 2021, the accused deliberately violated Section 77 of PD 705 as amended by RA 7161.

In view of the above, the undersigned recommended for filing of criminal case against the accused.

Further recommendation for the forfeiture of all forest products { 3 door jamb} and conveyance in favour of government.


