This pertains to the request of Mrs. Ludita B. Katon for the issuance of permit to cut naturally grown trees within a private land covered by Transfer Certificate of Title (TCT) No. 41044 located in Barangay San Manuel (formerly San Pedro), Puerto Princesa City.

Considering the merit of the request, PENRO/CENRO recommendations, compliance to documentary requirements of the applicant, and pursuant to the DENR Administrative Order No. 2022-10 dated 30 May 2022 re: "Revised DENR Manual of Authorities on Technical Matters", PRIVATE LAND TIMBER PERMIT (PLTP) NO. DENR MIMAROPA REGION-2023- 005% is hereby granted in favor of Mrs. Ludita B. Katon to cut two (2) naturally grown trees of various species within the above-cited titled property having a net harvestable volume of 2.01 cubic meters after deducting 30% allowance for internal defects and harvesting inefficiency as shown in the table below:

Pursuant to Memorandum Order No. 2012-02 dated 5 November 2012 known as "Uniform Replacement Ratio for Cut or Relocated Trees", the permittee is required to replace each tree to be cut with one hundred (100) seedlings, strictly of indigenous species with at least one (1) meter in height to be donated by the permittee to the CENRO concerned in support to the National Greening Program (NGP) and Climate Change initiatives of the Government.

Submit compliance monitoring report with geo-tagged photographs on the cutting operation together with the report of the permittee relative thereto for reference and record purposes.

Pursuant to P.D. 705, as amended, and existing forestry laws, rules and regulations, a **Private Land Timber Permit** is hereby granted to:

MRS. LUDITA B. KATON Barangay San Manuel, Puerto Princesa City

subject to the following conditions:

 Only two (2) naturally grown trees inspected/verified by CENRO Puerto Princesa City to be within Transfer Certificate of Title (TCT) No. 41044 shall be authorized to be cut;

- 2. Issues that will arise from the tree cutting should be addressed directly by the permittee;
- 3. The trees requested to be cut and parts thereof belong to the applicant subject to payment of forest charges. In case of the need to transport these, necessary transport documents shall be secured from the local DENR Office;
- 4. Prior to tree cutting operations, placard or signboard measuring 4' x 8' shall be installed in a conspicuous place within the cutting area to inform the public that the tree cutting is authorized by the DENR. Such notice of particulars shall include the name of permittee, purpose of the activity and the number of tree/s to be cut;
- 5. Consistent with Memorandum Order No. 2012-02 dated 05 November 2012 known as "Uniform Replacement Ratio for Cut or Relocated Trees", the permittee is required to replace each tree to be cut with at least one hundred (100) seedlings, strictly of indigenous species with at least one (1) meter in height to be donated by the permittee to CENRO Puerto Princesa City in support to the National Greening Program (NGP) and Climate Change initiatives of the Government;
- 6. The tree cutting operations shall, at all times, be under the direct supervision of the PENRO Palawan or his duly authorized representative(s).
- 7. The permittee shall be required to undertake measures during and after tree cutting operations to mitigate the possible impacts of the said activity to the locality and the environment; and
- 8. Violation of any of the terms and conditions of the permit shall be sufficient ground for the termination/cancellation of this permit, subject to due process without prejudice to the imposition of appropriate penalties pursuant to existing regulations, and one strike policy to concerned DENR official(s) and/or personnel(s).

This permit is effective upon receipt of the CENRO/Implementing PENRO and shall expire after fifty (50) days or as soon as the authorized number of tree/s is/are harvested and disposed of, whichever comes first.
