

Please be informed that BLISS Site located in Bgy. Sta. Monica, Puerto Princesa City is covered by approved Plan Csd-04-024890-D as surveyed for Sta. Monica BLCA, Inc. wherein the said plan is subject for cancellation and/or amendment in consideration with the association's decision to avail the Residential Free Patent Act or Republic Act No. 10023 and likewise for the reason that this Office observed that the actual occupation of its occupants does not conform unto the said approved plan.

In this regard, this Office is requesting whether the issuance of survey order is possible to address the aforementioned request and inconsistencies.

## DCC RESOLUTION No. 22-2002

A RESOLUTION APPROVING THE APPLICATION FOR FINAL APPROVAL AND ISSUANCE OF DEVELOPMENT PERMIT OF THE STA. MONICA BAGONG LIPUNAN COMMUNITY ASSOCIATION, INC., OF THEIR ON-SITE DEVELOPMENT PLAN, ON THE LAND DESCRIBED AS LOT 4203, CAD-800-D CONTAINING AN AREA OF THIRTY NINE THOUSAND TWO HUNDRED NINETY FOUR (39,294) SQUARE METERS, LOCATED IN BARANGAY STA. MONICA, CITY OF PUERTO PRINCESA.

WHEREAS, forwarded to this Committee by Engr. Rex G. Bundac, City Zoning Officer is the application of Sta. Monica Bagong Lipunan Community Association, Inc., represented by its Geodetic Engineer, Porferio P. Borja, for final approval and issuance of development permit of their on-site development plan, on the land described as Lot 4203, Cad-800-D containing a land area of 39,294 square meters, located in Barangay Sta. Monica, this City;

WHEREAS, in the meeting held on August 16, 2002, this Committee deliberated on issues pertaining to the application;

WHEREAS, the Committee recognizes the need to expedite the approval of the subdivision plan, provided it complies with the basic requirements under applicable laws and City Ordinances, and that the rights of the actual occupants are duly considered;

WHEREAS, during the review and verification, the committee finds the same to have complied with the minimum requirements and standard of the City Zoning Ordinance and BP 220;

NOW THEREFORE, on motion of Mr. Amaldo U. Favila, City Assessor duly seconded by Engr. Vicente C. Licerio Jr., City Engineer,

BE IT RESOLVED, as it is hereby resolved, to approve the application for final approval and issuance of development permit of the Sta. Monica Bagong Lipman Community Association, Inc., of their on-site development plan, on the land described as Lot 4203, Cad-800-D containing an area of 39,294 square meters located in Barangay Sta. Monica, City of Puerto Princesa, provided that all existing rights of occupants are duly respected.

RESOLVED FURTHER, that copies of this resolution be furnished Hon. V. Dennis M. Socrates, City Mayor, the Office of the Sangguniang Panlungsod, the City Zoning Officer and Porferio P. Borja-Geodetic Engineer, all of this City, for their information and/ or appropriate action.
