The Philippine Statistics Authority will conduct the 2022 Census of Agriculture and Fisheries (CAF), a large-scale government undertaking geared towards the collection and compilation of basic information on agricultural and fishery sectors in the Philippines, in 2023. It is the seventh in a series of decennial agricultural census and the sixth in the decennial census of fisheries in the country since 1903.

The census data to be collected such as number of agriculture, aquaculture, and fishing operators, number and area of farms/holdings and parcels, types of crops planted, among others, are important bases in policymaking and program planning for livelihood, food security, and socio-economic development of the country, which are vital to your eight-point socioeconomic agenda.

4. Undertake publicity and information drive among its personnel, stakeholders, and clientele by posting/sharing 2022 CAF information and publicity materials online through official websites and social media accounts, printing/posting of posters, streamers, and/or standees in office premises, and/or printing/distribution of 2022 CAF brochures and flyers.
