
Respectfully forwarding the report of the Lawin Data Manager concerning the abovementioned subject.

UPDATE ON THE INSTALLATION OF CYBERTRACKER ON

THE NEW LAWIN GADGETS

This pertains to the previously distributed Lawin Gadgets from Forest Management Bureau (FMB) wherein CENRO Socorro received five (5) units. To date, one (1) unit was directly given to Forest Ranger Adrean Castillo during the seminar. The three (3) units were transferred to Forest Rangers Rhona Liwag, Arnaldo Pudiquet and Norman Asi upon instruction from MES Chief and Enforcement Unit Head. The last one (1) is still available for transfer and under the care of the undersigned. The only working gadget being used during patrolling was one (1) official tablet of south sector and one (1) personal phone of the north sector. Also, we still need 129.54 kilometers to reach the 150-km target for the quarter.

Please be informed that the undersigned tried to install the cybertracker application to the new gadgets but no luck was made since the application keeps stopping and automatically close with the error message saying that the application was built for older version. Further, the following were the trials done to make the application work:

- Install in usual way using the Lawin system in laptop;
- Install using the .apk file generated from the Lawin system in laptop;
- Install using the working cybertracker from San Jose and got help from their data manager;
- Install using the application from the playstore;
- Install using possible combinations of the abovecited ways.

Relative thereto, the undersigned already raised the concern to the group chat but still no response. With this, may we request for the updated copy of cybertracker application that will work with the new phones or assistance in installation to make the application work.
