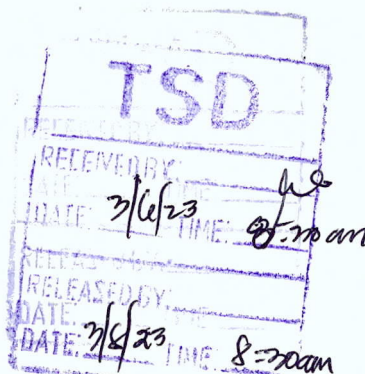

RESOLUTION No. 2022-72

This pertains to the apprehension of One (1) Unit STIHL Chainsaw without serial number color white and orange with an Oregon guide bar at Barangay Nicolas, Magsaysay, Occidental Mindoro on August 18, 2022, at around 6:00 in the evening

The facts of the subject case are as follows, to wit:

1. That, on August 18, 2022 past 6 o'clock in the evening Enforcement and Monitoring Section Chief, Forester Augreth S. Saligumba received a call from Magsaysay Municipal Police Station that they have apprehended a certain Mr. Victor Hermoso Palomo with possession of One (1) Unit STIHL Chainsaw without serial number color white and orange with an Oregon guide bar at Brgy. Nicoals, Magsaysay, Occidental Mindoro around 6:00 in the evening of the same day and believed to be illegal;
2. That, on August 19, 2022 at around 10:40 in the morning, the Magsaysay MPS had turned over to this office the apprehended one unit of STHIL chainsaw without serial number color white and orange with an oregon guide bar for safekeeping and proper documentation. (*Please see attached spot report*);
3. That, the corresponding Apprehension Receipt with CENRO Control No. 2022-F458 was issued by the apprehending officer Patrol Man Marvin O Tagupa (Magsaysay MPS) (*please see attached apprehension receipt*);
4. That, the Seizure Order with CENRO Control Number 2022-F458 was issued by the Seizure Officer, LMO III Rhodora A. Garcia (*please see attached seizure order*);
5. That, a criminal case was filed against Mr. Victor Hermoso Palomwith NPS Docket No. IV-06-INQ-22H-00493 for violation of the paragraph 1 of section 7 of the Republic Act No. 9175 (Chainsaw Act) ;
6. That, an invitation for an administrative adjudication dated August 19, 2022, was received by Mr. Victor Hermoso Palomo (*please see attached Letter*);

7. That, during administrative adjudication last August 24, 2022, Mr. Victor Hermoso Palomo acknowledged that he is the owner of said chainsaw however, he did not present any legal documents issued by this Office;
8. That, Mr. Jolito Zabala Casas stated that he is not aware of the facts that use or possession of chainsaw without any legal documents issued by the Department is a violation;

The issues to be resolved in this case are as follows:

1. Whether or not the One (1) Unit STIHL Chainsaw without serial number color white and orange with an oregon guide bar **will be confiscated in favor of the government.**

The grounds for apprehension and seizure of the equipment is valid, as the Chainsaw was not supported with any legal documents issued by the office of the DENR-CENRO San Jose, Occidental Mindoro.

CHAINSAW ACT (RA 9175)

Republic Act No. 9175, **AN ACT REGULATING THE OWNERSHIP, POSSESSION, SALE, IMPORTATION, AND USE OF CHAINSAW, PENALIZING VIOLATIONS THEREOF AND FOR OTHER PURPOSES**, states that;

Section 7. Penal Provisions.

1. Selling, Purchasing, Re-selling, Transferring, Distributing, or Possessing a Chain Saw without a Proper Permit. - Any person who sells, purchases, transfers the ownership, distributes, or otherwise disposes or possesses a chain saw without first securing the necessary permit from the Department shall be punished with imprisonment of four (4) years, two (2) months, and one (1) day to six (6) years or a fine of not less than Fifteen thousand pesos (P15,000.00) but not more Thirty thousand pesos (30,000.00) or both at the discretion of the court, and the chain saw/s confiscated in favor of the government.

Sec. 2. Items subject to apprehension, seizure, confiscation, and forfeiture.

- a. ***MACHINERY, EQUIPMENT, TOOLS, and IMPLEMENTS*** - used in the possession, gathering, collecting, processing, and/or transporting of illegal forest products;

DENR Administrative Order No. 2003-04 – Implementing Rules and Regulations of the Chainsaw Act of 2002 (RA NO. 9175) “An Act Regulating the Ownership, Possession, Sale, Importation and Use of Chainsaws, Penalizing Violations thereof and for other purposes.

Section 13. CONFISCATION OF CHAINSAWS-

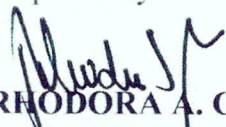
13.1 Chainsaws sold, purchased, resold, transferred, distributed, leased, rented, lent or possessed without proper permit or authority from the Department.

Wherefore, pursuant to the penal provision (Section 7) of Republic Act No. 9175, section 2 of DENR Administrative Order No. 97-32, series of 1997, section 13 of DENR Administrative Order No. 203-04 and based on DAO 2022- 10 (Manual of Authorities) the following is hereby recommended:

1. The One (1) Unit STIHL Chainsaw without serial number color white and orange with an oregon guide bar **shall be confiscated in favour of the government** since the chainsaw is a product of illegal/ no legal documents issued by the Department.

4. Who : The suspect identified as Victor Hermoso Palomo, 27 years old, male, married, laborer and resident of Sitio Calachuchi Brgy Alibog, Magsaysay Occidental Mindoro.
5. How : Investigation conducted disclosed that on August 18, 2022, about 5:00 PM, this station received information from our confidential asset that a person was seen carrying a chainsaw at the place of incident. Immediately, intel operatives of this Station led by PEMS Darius G Tolentino, Intelligence member were dispatched to respond to the report and the team caught the suspect Victor Hermoso Palomo, while carrying a chainsaw. When asked to present legal documents to possesses, the suspect admitted that his chainsaw has NO pertinent documents from the DENR. The suspect was arrested with one (1) unit of Chainsaw without serial number, color orange and white with blade marking OREGON and with an estimated amount of fifteen thousand (Php15,000.00) pesos was confiscated in his possession together with tools.
